NOTICE OF INTENTION TO OFFER LICENSE AGREEMENTS
PUBLIC AUCTION

The Fresno County Board of Supervisors on September 13, 2016 adopted the Resolutions of Intention to offer the License Agreements for Mobile Food Service Units on County owned property, located at University Medical Center and Courthouse Park. Two (2) agreements are to be offered with a term of five (5) years each. The public auction will be held on Wednesday, October 12, 2016 at 10:00 a.m., at the Board of Supervisors Chambers, Room 301, 2281 Tulare St., Fresno, CA 93721. The minimum bid is \$5,000 per year for University Medical Center. The minimum bid is \$12,000 per year for Courthouse Park. All written bids must be delivered to the Clerk of the Board by 10:00 a.m. of the day of the auction in a sealed envelope labeled either "(Bid for UMC)" or "(Bid for Courthouse)" accompanied by a certified or cashier's check of \$1,000 payable to the County of Fresno for each of the two agreements, University Medical Center and Courthouse Park. Oral bids will be accepted after written bids are opened. Oral bidders must submit a certified or cashier's check for \$1,000 if they have not already done so.

Copies of the Board resolutions are on file for public review at the Board of Supervisors Chambers bulletin board. The resolutions contain the instructions for bidding and the terms of each individual agreement for each site.
