FOR THE CITY OF PARLIER. )

WHEREAS, in the later part of 1967, the California Public Utilities Commission (CPUC) decided Case No. 8209 which established a program commonly referred to as an "Undergrounding Program" and under which directed that all privately (investor) owned electrical utility companies provide an allocation of their earnings in the form of credits each year to cities and counties which maintain an active Underground Utility District (UUD) program for the conversion of overhead utilities to underground; and

WHEREAS, Pacific Gas and Electric Company's (PG&E) program commonly referred to as the Rule 20A Program (Rule 20A) provides that uncommitted credits in a county's undergrounding account may be transferred to a city or cities within a county with the county's approval; and

WHEREAS, PG&E's program provides that uncommitted carryover of Rule 20A credits above a certain level in each community may be reallocated to those communities with an active UUD program; and

WHEREAS, on January 10, 2006 the Board of Supervisor's (Board) of the County of Fresno (County) adopted Resolution # 06-013 approving the transfer of County Rule 20A credits in the amount of \$750,000 to be allocated to the City of Parlier for the Mendocino Avenue Project from Manning Avenue to Parlier Avenue (Mendocino Avenue Project); and

WHEREAS, on April 28, 2009 the Board adopted Resolution #09-164 approving the transfer of County Rule 20A credits in the amount of \$920,000 to be allocated to the

1 City of Parlier for the Parlier Avenue Project from Academy Avenue to Madsen Avenue  
2 (Parlier Avenue Project); and

3 WHEREAS, the City of Parlier requests that the Board approve the transfer of  
4 County Rule 20A credits in the amount of \$920,000 from the Parlier Avenue Project to  
5 the Mendocino Avenue Project; and

6 WHEREAS, the City of Parlier will be responsible for the difference over and  
7 above the allocated County Rule 20A credited in the amount of \$920,000; and

8 WHEREAS, The City of Parlier shall return any unused portion of said County  
9 Rule 20A credits allocated to the City of Parlier for the completion of the Mendocino  
10 Avenue Project upon the closing of the Mendocino Avenue Project by PG&E.

11 NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the  
12 County of Fresno (Board) that each of the foregoing recitals is true and correct.

13 BE IT FURTHER RESOLVED that the Board hereby authorizes PG&E to transfer  
14 the County Rule 20A credits in the amount of \$920,000 from the Parlier Avenue Project  
15 to the Mendocino Avenue Project for the City of Parlier to facilitate the completion of  
16 undergrounding the existing overhead utilities of that portion of the Mendocino Avenue  
17 Project.

18 BE IT FURTHER RESOLVED that the Board hereby requests that upon the  
19 closing of the Mendocino Avenue Project by PG&E that the City of Parlier return any  
20 unused portion of said County Rule 20A credits allocated to the City of Parlier for the  
21 completion of the Mendocino Avenue Project.


22 BE IT FURTHER RESOLVED that if the allocated Rule 20A credits in the amount  
23 of \$920,000 are not used for the Mendocino Avenue project by October 11, 2018 then  
24 the City of Parlier must return the full amount of the allocated Rule 20A credits for the  
25 Mendocino Avenue Project back to the County.
