Notice is hereby given that the Board of Supervisors of the County of Fresno has set this hearing for Tuesday, October 18, 2016, 9:00 a.m. or as soon thereafter at the Board of Supervisors Chambers, Room 301, Hall of Records, 2281 Tulare St., Fresno, California as the time and place for holding a public hearing on the following matters:

Rezone a 38.03-acre parcel from an AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District to an AL-20 (Limited Agricultural, 20-acre minimum parcel size) Zone District. The Applicant proposes to submit a subsequent Conditional Use Permit Application at a future date to permit the establishment of a Personal/Recreational Vehicle Storage in the AL-20 Zone District. The project site is located on the northwest corner of E. Copper Avenue and Auberry Road, approximately 2,800 feet east of the nearest city limits of the City of Fresno (SUP.
