WHEREAS, appropriations in the amount of \$92,531 are needed for the FY 2016-17 Library-Measure B Organization 7511 for prior year commitments that were not fully expended in the prior year budget; and

WHEREAS, the \$42,531 is available in fund balance of the Fresno County Library Measure B Fund 0107, General Subclass 10000; and

WHEREAS, the remaining \$50,000 will be received as an Operating Transfer In from the Public Works & Planning Fund 0085, County Parks Donations Subclass 17411, County Parks Donations Org 1191 upon completion of the project; and

WHEREAS, the Fresno County Library-Measure B fund shall be used exclusively for public library construction, acquisition, programs, and operations within the County; and

WHEREAS, said monies are not included in the FY 2016-17 adopted appropriations and estimated revenues of the Library-Measure B Organization 7511; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

1 NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax
2 Collector is authorized to increase the appropriations in the FY 2016-17 Library-
