RESOLUTION AUTHORIZING
RESCISSION OF AGRICULTURAL LAND
CONSERVATION CONTRACT (ALCC) NO.
6495 AND ENTRY INTO AGRICULTURAL
LAND CONSERVATION CONTRACT NO.
8318

17 WHEREAS, Agricultural Land Conservation Contract (ALCC) No. 6495 was entered
18 into between the County of Fresno and Cuyler H. Leonard, hereafter referred to as "Owner",
19 and recorded February 17, 1978 as Instrument No. 18117, Book 6974, Pages 528 through 530
20 in the Official Records of Fresno County, California; and

21 WHEREAS, Owner wishes to adjust parcel lines between two existing parcels resulting
22 in parcel sizes of 7.54 and 71.89 acres and through rescission of existing Agricultural Land
23 Conservation Contract No. 6495 and simultaneous execution of new Agricultural Land
24 Conservation Contract No. 8318, remove a 71.89-acre parcel known as APN 313-410-13 from
25 the Williamson Act program and execute a new contract for the parcel described in Exhibit "A"
26 attached to this Resolution; and

27 WHEREAS, Section 51257 of the California Government Code provides a process
28 where parties may upon their mutual agreement rescind a contract in order to simultaneously

1 enter into a new contract which would enforceably restrict the same property for an initial term
2 at least as long as the unexpired term of the contract being so rescinded but no less than 10
3 years; and

4 WHEREAS, the parcel covered by Agricultural Land Conservation Contract No. 8318
5 as described in Exhibit A attached to this Resolution, shall be subject to all restrictions and
6 conditions of the Interim Guideline adopted by the resolution by the Board of Supervisors of
7 Fresno County, California on May 25, 2004, as well as the Williamson Act Permitted Uses,
8 Compatible Uses, and Conditioned Compatible Uses adopted by resolution by the Board of
9 Supervisors of Fresno County, California on October 25, 2011.

10 NOW, THEREFORE IT IS HEREBY RESOLVED that the Board of Supervisors of the
11 County of Fresno approves rescission of Agricultural Land Conservation Contract No. 6495,
12 and the simultaneous entry into Agricultural Land Conservation Contract No. 8318 and
13 authorizes the Chairman to execute said contract. The Clerk to the Board of Supervisors shall
14 cause a certified copy of this resolution to be recorded together with the executed Contract in
15 the Office of the County Recorder for the County of Fresno.

16 THE FOREGOING was PASSED and ADOPTED by the following vote of the Board of
17 Supervisors of the County of Fresno this 13th day of December 2016, to-wit:


