WHEREAS, the County of Fresno received funds in the amount of \$754,284.53 from the Ernest Lawrence estate on March 7, 2012, of which \$140,000 is proposed to be allocated for the purchase and installation of playground structures at Lost Lake Park and Skaggs Bridge Park; and

WHEREAS, the Parks and Grounds Org 7910 will receive these funds as an Operating Transfer In from the Public Works and Planning Special Revenue Fund 0085, Subclass 17411, County Parks Donations Org 1191 to fund the project; and

WHEREAS, said monies are not included in the FY 2016-17 adopted appropriations and estimated revenues of the Public Works and Planning, Parks and Grounds Organization 7910; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Public Works and Planning, Parks and Grounds Organization 7910 as follows:


