Dear Supervisor:

Consent Item 19 tomorrow brings forward the certified Statement of Vote from the November 2016 election for your acceptance. The item also includes the Official Final Results report.

Just a clarification, the Official Final Results report format has been used for the past 17 years. In each race, the highest vote getter (whether it be a candidate or "yes" or "no" on a measure) is highlighted in bold type. As you know, different types of local measures require a certain percentage to "pass" or "fail". Beginning in 2014, to provide the public as much information as possible, we also included in the identifying local measure title the percentage required for "pass" or "fail". We continued this tradition this year.

As an example, Measure M for City of Kerman required a 2/3's percent to pass. While the measure received the largest amount of votes in the "yes" category (hence the "yes" is shown in bold), the total amount of "yes's" did not surpass 66.67% of all votes, therefore this measure failed.
