Notice is hereby given that at its regularly scheduled meeting on December 6, 2016, the Fresno County Board of Supervisors adopted AN INTERIM URGENCY ORDINANCE, PROHIBITING THE POSSESSION, PLANTING, CULTIVATION, HARVESTING DRYING, OR PROCESSING OF NONMEDICAL MARIJUANA OUTDOORS ON THE GROUNDS OF A PRIVATE RESIDENCE AND THE ESTABLISHMENT OR OPERATION OF BUSINESSES ENGAGED IN COMMERCIAL MARIJUANA ACTIVITY IN ALL ZONING DISTRICTS OF FRESNO COUNTY.
