WHEREAS, the County has continued a resolution of the local emergency status relating to the extremely high levels of tree mortality and hazardous conditions created by the drought and requested that the Governor continue to provide resources and support to mitigate risks of falling trees and increased fire hazards; and

WHEREAS, the County of Fresno has applied for and will receive \$400,000 from the California Department of Forestry and Fire Protection Tree Mortality Grant Program for two separate revenue agreements; and

WHEREAS, said monies are not included in the FY 2016-17 adopted appropriations and estimated revenues of the County Service Area 31B Shaver Lake Treatment Org 9166 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 County Service Area 31B Shaver Lake Treatment Org 9166 as follows:




