17 WHEREAS, within one year after the recordation of the Tax Collector's deed to the
18 purchaser, **Global Discoveries, Ltd** (claimant) filed with the County a claim for the excess
19 proceeds from the sale of the property; and,

20 WHEREAS, the claim filed contains sufficient information and proof to establish, to
21 the satisfaction of the Board of Supervisors, claimant's right to **\$57,479.29** of the excess
22 proceeds under California Revenue and Taxation Code Section 4675.

23 NOW, THEREFORE, IT IS ORDERED that (1) **\$57,479.29** of the excess proceeds
24 shall be distributed to claimant, (2) the Auditor-Controller/Treasurer-Tax Collector shall
25 accomplish that distribution by issuing a check to claimant for **\$57,479.29**, and (3) Address
26 to be mailed: **P O Box 1748, Modesto CA 95353**
