

Background



Highway City Community Development was born in 1983 as Highway City Thrift Store through a vision of Northwest Church on the West side of Highway 99 in Fresno, Ca. It was a place for the community to buy quality items for an affordable price. The store also sponsored AWANA programs and 5 Days of Fun, a summer enrichment program for children.

In 1991, Northwest church purchased a plot of land west of the 99, near Gettysburg & Polk for future development, and then in 1992, the Thrift store moved to its current location at 5472 W. Shaw Ave, near Polk. Dignity based work programming was started at the store in 1995, and it continues in expanded formats to include work experience, job training and life skills-preparing people to be job ready.

In 1996 Northwest launched the beginnings of a church in the same Highway City area to serve the needs of the neighborhood. Highway City church was located on State Street and worked in conjunction with the store. To better serve the neighborhoods, and expand services, a non-profit arm was created; Highway City Community Development. It was quickly realized that Highway City church was too small to serve the needs of the community and was relocated to the cafeteria of Central High School in a partnership with Central Unified School District.

Amazingly, as the story unfolds, in 2001, the land that Northwest church had purchased sat next to a church that was for sale, located across from Teague Elementary. In a capital campaign, Northwest church matched funds that Central Community Church raised, and the church was purchased right next to the open land, that was then quick deeded to CCC.

2004 brought the vision of building on the property that is shared by HCCD & CCC, and community input was gained. A community center that would have access and resources for youth and seniors was drawn into a plan as well as more buildings for the church, and outdoor fields. However, as the vision grew, the economy worsened, and the vision lay dormant.

Two years ago, the vision was recast and plans to move forward started again for the center that would focus on literacy, health care and needs of the families in the area. Networking created partnerships, and community input again showed that the center was on target for need. *Today we are focused on bringing the center to life, as a step towards helping the community thrive.*

Resources for families in the area also include Inner-city Afterschool and Summer Enrichment programs, as well as English Learning Classes, Budgeting Courses and children's activities (Saturday Sports & Recreation). A monthly Farmer's Market Food Distribution provides healthy additions to families in need. We are direct partners to Central Unified to work with families in crisis to help provide the resources to help change

The City of Fresno's vision and our alignment:



The city's 2035 General Plan shows a reality that our "community faces a long and difficult journey back to health". The plan calls for only half of the growth in the next twenty years to be new, while the other half occurring in existing neighborhoods, which is a departure from previous plans. Restore Fresno 2016 is an initiative that focuses on improving property values, living conditions, public safety and the overall quality of life in our older neighborhoods. The tools available to make these changes include land use policy, code enforcement, targeted public infrastructure investments, collaborations of public & private sectors and grants. The foundational elements of revitalization include a targeted plan for the West of 99 "Growth in Area 1" specific plan.

Realizing that the city had a focus on the area West of 99, and that thoughts of revitalization, restoration and infrastructure were not just a pipe dream, we continue to march forward in being change makers in our community.

Developing a strategic plan:

Research, analysis and community input have all been part of an ongoing process to make sure that the land and our resources will be used to its optimal potential.

In doing so, the current developmental focus has been on:

Recognizing areas of need in the Central Unified/West of 99 area and bringing sustainable change to that area.

Resourcing need: Children, Literacy, Healthcare options

Reducing blight, increasing positive infrastructure: housing, greenspace, and infill

Neighborhood revitalization through empowerment.

In the past several years, new housing developments have been erected in the West of 99 area, as well as additional schools in the Central Unified School District to support the growth. Future housing developments show multiple tracts being raised in the next five plus years, however other resources and infrastructure are not plentiful to this growing community – a community with a diverse demographic in culture, economy, and need.

Living west of the 99, you can visually see the lack of resources.



An unsettling reality is- *"If you live past the railroad tracks, and there was an emergency that cut you off from the rest of the city, would we have the resources to sustain ourselves?"* What's missing?

Analysis & Research:

With the population of a mid-sized town at over 38,000 residents (*only includes Central Unified areas within census tracts west of 99*), the need to bring sustainable resources is paramount to a healthy community. A sustainable community is defined as being economically, environmentally and socially healthy with resources that are equitably available for future generations.

West of the 99, where many families have mobility issues, the following are areas of change or need:

Grocery stores – 2

Doctors/urgent Care – 1 (VHT will open late 2017)

Dental/Optical/Chiropractic services - 0

Libraries – 1 satellite location open limited hours/access at

Teague Elementary

Parks/Green Space – 2

Bus routes – 1 (*route, limited coverage*)

Banks/Credit Unions – 2

Payday loan operations - 3 (*reduce*)

Liquor Stores – 15 (*reduce*)



While many neighborhoods in the Central Unified/West of 99 thrive, there are still many pockets of poverty, low mobility and a higher lack of resources than other areas.

Five census tracts in the Central Unified area average over 22% poverty.

The worst tract in the area comes in at over 39%. Average median Income of those five tracts is at \$45.5K (*Census Tract 2010, Fresno Hunger Count Survey 2014, city-data.com*)

66% of the students at Central Unified qualify for free/reduced lunches

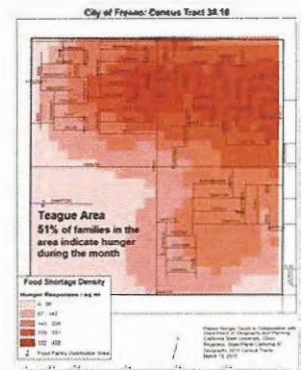
Largest waitlisted area for services at Headstart preschools.

On average, 400 students are categorized as homeless on any given day in Central Unified.

5300+ people served in a year at monthly Farmer's Market style food distribution, average 200+ families per month

In struggling tract areas, 16-31% of students have no internet access, and in the struggling areas, only 59-65% of parents list college as a goal vs. 83-85% in higher performing areas with access to resources.

Tract areas of poverty show high concentrations of monthly food insecurity.

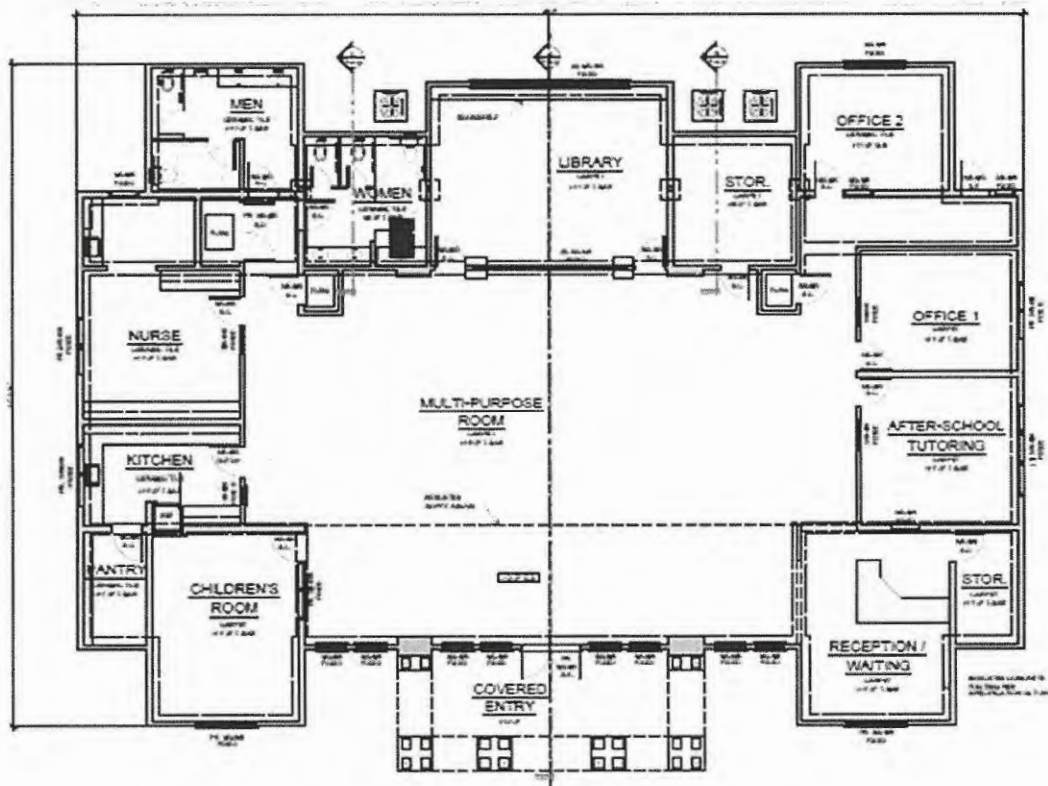

On behalf of the City of Fresno and City Council District 1, I give my support for the proposed mixed -use development for housing and professional building that would include a Fresno County Library and community center.

As the City Councilmember of the district being considered, I have made this area a priority. Within the first few months of my taking office, this area west of the 99, stood out for its lack of basic infrastructure, transportation and service's needs.

The area immediately surrounding is served by Central Unified School District's elementary school. The school demographics is 70% minority with 91% of the school's students eligible for free/reduced price lunches. Less than 5% of the population earning a college degree.

The City of Fresno recently invested over \$10 million in a universally accessible park ½ mile from the proposed library site. This fiscal year I committed funds to provide engineering studies to identify and begin the process of providing the needed street and neighborhood improvements. Improvements to include; curb, gutter, sidewalk and the necessary road drainage.

I ask that you support this plan and approve the motion to bring the funding to the project that would provide the services of the Fresno County Library as a full-time operation providing County Library resources for the first time within the West of 99/Central Unified area.
