Staff is recommending Water Conservation Stage Four, because the capacity of the WWD 40 water system has been unable to meet usage demands during high use months. For this reason, the continued use of the private out-of-district well as a backup water supply is still necessary. In addition, the implementation of Stage Four may make WWD 40 eligible for further emergency drought-related grants from the State.
