WHEREAS, the Department of Social Services has identified the need to increase appropriations for contracting psychosocial assessments for current licensed foster care providers and those applying for foster care licensing; and

WHEREAS, the Department of Social Services Organization 5610 will receive \$596,250 as an Operating Transfer In from the Protective Services Subaccount Organization 6210 to the fund these expenditures; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2016-17 Department of Social Services Organization 5610; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Department of Social Services Organization 5610 as follows:


