OF \$596,250)

WHEREAS, the Protective Services Subaccount Organization 6210 requires additional appropriations to fund an Operating Transfer Out to the Department of Social Services Organization 5610 in the amount of \$596,250 to meet expenditures associated with additional psychosocial assessment services required of applicants to become foster care providers; and

WHEREAS, \$596,250 is available in the fund balance of the Local Revenue Fund 2011 Special Revenue Fund 0271, Subclass 13030 to fund these expenditures; and

WHEREAS, \$596,250 is not included in the FY 2016-17 adopted appropriations of the Protectives Services Subaccount Organization 6210 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Protective Services Subaccount Organization 6210 as follows:


