WHEREAS, said monies are not included in the FY 2016-17 adopted
appropriations and estimated revenues of the Department of Public Health
Organization 5620; and

WHEREAS, Section 29130 of the Government Code provides for the
appropriation of these funds by a four-fifths vote of the Board of Supervisors;

Controller/Treasurer-Tax Collector is authorized to increase the appropriations in




