

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations. Pursuant to Labor Code section 1771.1, any Contractor bidding, or subcontractor to be listed on a bid proposal subject to Public Contract Code Section 4104, shall not be qualified to bid unless currently registered and qualified to perform public works pursuant to Labor Code section 1725.5. No Contractor or subcontractor may be awarded a contract or perform work on any contract for public work without proof of current registration with the Department of Industrial Relations pursuant to Labor Code Section 1725.5 to perform public works. The work to be done consists, in general, of removing and salvaging existing traffic signal and lighting equipment, installation of new traffic signal facilities, including but not limited to, signal heads, controller, electrical service equipment, conduits, and wiring at the intersection of Fruit Avenue and Barstow Avenue. The work also includes, but is not limited to, clearing and grubbing, root barrier installation, construction of sidewalks, curb returns and ramps, modification of pavement markings and striping, cold planing, adjusting manholes to grade and finishing the roadway.
