Operating Transfer In from the Indian Gaming Special Distribution Fund (IGSDF)  
ORG 3120 for reimbursement of prior FY expenditures; and

WHEREAS, \$66,683 is not included in the appropriations and estimated  
revenues of the Sheriff-Coroner Org 3111 for the FY 2016-17; and

WHEREAS, Section 29130 of the Government Code provides for the  
appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-  
Tax Collector is authorized to increase the appropriations in the FY 2016-17  
Sheriff-Coroner Org 3111 as follows:
