RESOLUTION

WHEREAS, the Department of Behavioral Health, CSS Org 1051 requires \$643,153 to meet expenditures associated with the Turning Point of Central California, Inc. Agreement for the provision of Mental Health Services Act Full Service Partnership, Intensive Case Management and Outpatient Mental Health Services; and

WHEREAS, sufficient funds are available in the Fund Balance of the Mental Health Services Act Fund 0040, Subclass 17101 to fund these expenditures; and

WHEREAS, \$643,153 is not included in the FY 2016-17 adopted appropriations of the CSS Org 1051; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Budget of the CSS Org 1051 as follows:
