WHEREAS, the American Avenue Disposal Site Organization 9026 requires additional funds in the amount of \$50,000 to pay for unanticipated cost of leachate pumping and disposal; and

WHEREAS, \$50,000 is available in the American Avenue Disposal Site Fund 0700, Subclass 15000 to fund these unanticipated costs; and

WHEREAS, said monies are not included in the adopted appropriations for the FY 2016-17 American Avenue Disposal Site Organization 9026; and

WHEREAS, Section 29130 of the Government Code provides for the appropriations of these funds by a 4/5ths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Budget for American Avenue Disposal Site Organization 9026 as follows:


