WHEREAS, on the basis of the whole record before the Board of Supervisors. including any comments received, there is no substantial evidence that this amendment to the General Plan will have a significant effect on the environment; and

WHEREAS, this will be the first amendment cycle to the Fresno County General Plan in this calendar year.
