WHEREAS, the Public Works & Planning Organization 4360 requires funding in the amount of \$1,257,000 for the design and construction of various projects throughout the County; and

WHEREAS, various County Departments will reimburse Public Works & Planning Organization 4360 for the authorized budgeted projects; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2016-17 Public Works & Planning Organization 4360; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors.






