

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations. Pursuant to Labor Code section 1771.1, any Contractor bidding, or subcontractor to be listed on a bid proposal subject to Public Contract Code Section 4104, shall not be qualified to bid unless currently registered and qualified to perform public works pursuant to Labor Code section 1725.5. No Contractor or subcontractor may be awarded a contract or perform work on any contract for public work without proof of current registration with the Department of Industrial Relations pursuant to Labor Code Section 1725.5 to perform public works. The work to be done consists, in general, of placing a hot mix asphalt concrete overlay, traffic striping, shoulder widening and shoulder backing (excluding Flood Zone A) on approximately 10.6 miles of existing roads in Fresno County. The Disadvantaged Business Enterprise Contract Goal is 8 percent.
