The Agreement will be for two years, July 1, 2017 – June 30, 2019 with a total term cost of \$729,300.
4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.
Services allow for customized training tailored to the County of Fresno to meet the training requirements. Additionally, UC Davis is the only one that offers Child Welfare and Eligibility training.

6. Explain why the unique qualities and/or capabilities described above are essential to your department.
Training services are required in accordance with the Department's State Annual Training Plan mandated by the State of California, Health and Human Services Agency and the Department of Social Services, Manual of Policies and Procedures, Chapter 14, Staff Development and Training (MPP Chapter 14) and 45 CFR 235.62.
7. Provide a comprehensive explanation of the research done to verify that the recommended vendor is the only vendor with the unique qualities and/or capabilities stated above. Include a list of all other vendors contacted, what they were asked, and their responses.
The Regional Training Academy (RTA) is the main social services training provider for County Social Services Departments and is composed of five regions. All five regions mainly provide Child Welfare training. Currently, the Department has three contracts with the California State University, Fresno Foundation (CSUF) to provide Child Welfare trainings. CSUF is one of the five RTA, yet is unable to provide all the trainings required by the Department, MPP Chapter 14 and 45 CFR 235.62. The Regents of University of California Center for Human Services, UC Davis Extension is the only RTA offering Eligibility and specialized training. Examples of specialized training requested by the Department are leadership, management, and supervisory training.
