AN ORDINANCE AMENDING THE MASTER SCHEDULE OF FEES, CHARGES AND RECOVERED COSTS FOR COUNTY SERVICES ("MASTER SCHEDULE OF FEES"). THIS ORDINANCE AMENDS SECTION 1000 - COMPUTER SERVICES (EMIS); SECTION 1500 - PARKS AND RECREATION; AND SECTION 2200 - PUBLIC WORKS.

The Board of Supervisors of the County of Fresno ordains as follows:

Section 1: The Master Schedule of Fees, Charges and Recovered Costs Ordinances is hereby amended as to Section 1000-Computer Services, Section 1500-Parks and Recreation and Section 2200-Public Works. Section 1000 is updated as to subsection 1001 to read in its entirety as set forth in Exhibit A, attached hereto and incorporated by reference; Section 1500 is updated as to subsection 1509 to read in its entirety as set forth in Exhibit B, attached hereto and incorporated by reference; Section 2200 is updated as to subsections 2207, 2208, and 2209 to read in its entirety as set forth in Exhibit C, attached hereto and incorporated herein by reference.

Section 2: This ordinance shall take effect 30 days after the second hearing.



Drainage Costs and Fees</b>		Local drainage fees required by Chapter 17.64 of Title 17 of the Fresno County Ordinance Code are calculated in accordance with a schedule of per gross acre fees. The fee applicable to any parcel of land or division shall be the product of the gross acreage of the parcel or division multiplied by the rate or rates per gross acre applicable to the land use district, local drainage area and local drainage area zone within which the parcel or division is located. The per gross acre rates and estimated total cost of the planned local drainage facilities are set forth on a separate schedule. Copies of that schedule are kept and maintained in the offices of the County Public Works Department, County Auditor-Controller/ Treasurer-Tax Collector, and Clerk to the Board of Supervisors.
