Dear Ms. Reyes:

On May 5, 2017, the Fresno County Clerk to the Board received a letter dated May 1, 2017 from Alcoholic Beverage Control (ABC) stating that Red Rock Lane Investments, dba Stonehouse Tavern had submitted a petition to modify or remove conditions on their alcoholic beverage license. Per that letter, Fresno County must file a written objection to the modification/removal of these conditions within 30 days.

On May 10, 2017, Ronald Alexander with the County Administrative Office sent you an email objecting to the modification at that time with the sole purpose of providing sufficient time to bring an agenda item to the Fresno County Board of Supervisors to discuss and make a determination. This was scheduled for the first meeting in June.

On June 6, 2017, the Board of Supervisors met and discussed this petition. The Board approved the removal of the condition that there shall be no live or amplified music allowed in the patio area at any time. Fresno County does have a noise ordinance. Stonehouse Tavern must abide by the noise ordinance regardless of whether or not there are conditions on their ABC license. The company will work with the Fresno County Environmental Health Department to ensure adherence to the noise ordinance.


