17	WHEREAS, the Fiscal Year 2016-17 appropriations limit for CFD 2006-01 was		
18	\$296,797,970; and		
19	WHEREAS, for CFD 2006-01, this Board desires to establish the adjusted		
20	appropriations limit for Fiscal Year 2017-18; and		
21	WHEREAS, at least 15 days before the date of the Board meeting at which the		
22	Board adopted this resolution, the documentation and calculations used to determine		
23	the appropriations limit for CFD 2006-01 stated in this resolution were made available		
24	for public inspection in the office of the Clerk to the Board and the Fresno County		
25	Sheriff's Business Office; and		
26	WHEREAS, before adopting this resolution, the Board gave the public, including		
27	any affected taxpayers with respect to CFD 2006-01, the opportunity to present any		
28	evidence or testimony for or against the Board taking such action.
