

On June 6, 2017, the County conducted the first hearing of the Ordinance to amend the Fresno County Master Schedule of Fees, Charges and Recovered Costs, which amends section 1100 - Library, relating to recovery of costs for Library Services where subsections 1107, 1111 and 1114 are deleted, subsections 1113, 1115, 1117 and 1118 remain unchanged, subsections 1101, 1103, 1108, 1110 and 1112 are updated, and

1122 are added.
