second hearing for June 20, 2017 This ordinance amendment is pursuant to the Memorandum of Understanding (MOU) between the County and the cities within the County which provides for an annual adjustment to the sales and use tax sharing ratio between the County and the cities within the County. The proposed ordinance will change the sales and use tax ratio of the one-percent Sales and Use Tax returned to the County and the cities by the State Board of Equalization for the City of Fresno from 0.9468 to 0.9469. The proposed ordinance will also change the dates to which all cities within the County must adhere to the stated

rates from July 1, 2017 to July 1, 2018


