- (4) Find that the proposed vacation is consistent with the General Plan adopted by the County of Fresno.
- Order that the right-of-way described in Exhibit "A" is vacated such that it no longer constitutes public right-of-way.
- Direct that the Clerk to the Board record this Resolution in accordance with Section 8336 of Chapter 4 Part 3 Division 9 of the Streets and Highways Code.

All of that 40-feet wide public right-of-way of DeWolf Avenue from the north right-of-way line of Shepherd Avenue, continue northerly approximately 5792-feet (1.10 miles) to the south right-of-way line of Behymer Avenue. Located in Section 23, Township 12 South, Range 21 East, Mount Diablo Base and Meridian. **Containing 5.32 acres, more or less.**

All of that 40-feet wide public right-of-way of Behymer Avenue from the west right-of-way line of DeWolf Avenue, continue easterly approximately 2650-feet to the west right-of-way line of Leonard Avenue. Located in Sections 23 and 14, Township 12 South, Range 21 East, Mount Diablo Base and Meridian. **Containing 2.43 acres, more or less.**

All of that 40-feet wide public right-of-way of Leonard Avenue from the south right-of-way line of Behymer Avenue, continue northerly approximately 1340-feet where the County road dead ends. Located in Sections 13, 14, 23 and 24, Township 12 South, Range 21 East, Mount Diablo Base and Meridian. **Containing 1.23 acres, more or less.**
