Total cost is \$125,000. The initial term cost is \$95,000 with \$15,000 for year 2 and \$15,000 for year 3.

6. Explain why the unique qualities and/or capabilities described above are essential to your department.

The website proposed under this agreement will provide residents the ability to locate which of the mosquito abatement districts their property is located in, identify appropriate contact information for reporting mosquito activity, and educational information related to Zika and other mosquito borne illnesses. The public outreach and education funding will allow FWMAD to hire an employee dedicated to providing Zika related information including awareness and prevention, potential health effects, especially to pregnant women, and identification of mosquito abatement and health related resources. These services were identified as necessary to assist the local mosquito abatemend districts in addressing potential Zika related concerns. Additionally, the additional resources provided through this agreement will assist the Department in preventing and mitigating effects of Zika virus disease in Fresno County.

- 7. Provide a comprehensive explanation of the research done to verify that the recommended vendor is the only vendor with the unique qualities and/or capabilities stated above. Include a list of all other vendors contacted, what they were asked, and their responses.
 - The Department regularly meets with the local mosquito abatement district managers. FWMAD, Fresno Mosquito and Vector Control and Consolidated Mosquito Abatement District mutually determined that FWMAD was the best suited of the three agencies to undertake provision of the services identified in the contract. No additional research was completed as it was determined by the Department that the services could be best administered by one of the local mosquito abatement districts due to their area of expertise and because FWMAD is a local governmental agency.
