IN THE AMOUNT OF \$800,000 )

WHEREAS, funding is required to remediate, restore and reconstruct the Fresno County Plaza Building as a result of flood damage resulting from a backed up HVAC drain; and

WHEREAS, funding is required to remediate the University Medical Center as a result of flood damage on multiple floors caused by flooding of the Air Handler system; and

WHEREAS, said additional costs will be financed by revenue from insurance proceeds in the amount up to \$25,000 per incident from the Risk Management Fund-Property Insurance Program and up to a maximum of \$775,000 from the County's excess insurance carrier; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2017-18 Facility Services, Org 8935 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Facility Services, Org 8935 as follows:




