King of Kings Community Center is currently a provider for the County of Fresno Department of Behavioral Health under the following contracts: A-16-295, Adult and/or Perinatal Residential Services; A-16-360, Master Agreement for Drug Medi-Cal Treatment Services; A-16-361, Non Drug Medi-Cal Services; and A-15-300, Sober Living Housing Services (hereinafter the "Agreements"). Pursuant to the Agreements, the County of Fresno and King of Kings Community Center hereby voluntarily terminates all four agreements immediately without cause. DBH-SUD Services will accept King of Kings' voluntary termination of the Agreements. Please sign below where indicated to confirm King of Kings' voluntary termination of the Agreements.

Within three (3) working days of this notification, King of Kings Community Center must:

1. Submit to DBH a list of all County beneficiaries who were enrolled in their program within the last five (5) years and prepare for transfer all confidential beneficiary information to the appointed DBH staff.
2. Submit an updated asset inventory report and schedule an appointment with the Analyst to retrieve the listed assets.
3. Submit final invoices and reports, including waitlists, census, DMC status report, client roster and other reports, as applicable.
4. Complete CalOMS and DATAR reporting requirements and submit to DBH any additional reports, as requested and in compliance with contract requirements.

Furthermore, King of Kings Community Center will submit accurate and complete cost reports for FY 16/17 services within the timelines prescribed by, and on forms approved by, the County of Fresno and the State Department of Health Care Services.

Additionally, in order to ensure uninterrupted treatment services for your clients, please immediately facilitate the transfer of clients to alternative providers as appropriate. A list of County contracted providers is included as Attachment 1.




