2	THIS AGREEMENT for Engineering Consultant Services, hereinafter referred to as
3	"the AGREEMENT," is made and entered into this <u>12th</u> day of <u>September</u> 2017,
4	between the COUNTY OF FRESNO, a political subdivision of the State of California,
5	hereinafter referred to as "the COUNTY"; and O'Dell Engineering, Inc., a California
6	Corporation, whose address is 1360 E. Spruce Avenue, Suite 101, Fresno, CA 93720,
7	hereinafter referred to as "the CONSULTANT".
8	WITNESSETH
9	WHEREAS, the COUNTY desires to retain the CONSULTANT to provide on-call
10	engineering consulting services, encompassing structural, mechanical, transportation,
11	environmental, water resources, surveying, geotechnical and other engineering disciplines,
12	as necessary to assist the COUNTY in performing projects (hereinafter referred to as "the
13	PROJECT(S)") proposed by the COUNTY; and
14	WHEREAS, said the CONSULTANT has been selected in accordance with the
15	COUNTY's Ordinance Code Chapter 4.10 on the selection of architects, engineers, and
16	other professionals, and in accordance with Chapter 10 of the California Department of
17	Transportation's (CALTRANS) Local Assistance Procedures Manual (LAPM), to provide
18	the engineering services necessary for the PROJECTS; and
19	WHEREAS, the individual listed below

25	COUNTY, and shall remain so unless the CONSULTANT is otherwise notified in writing by
26	the COUNTY's Director of Public Works and Planning or his/her designee (hereinafter
27	referred to as "the DIRECTOR"); and

7	shall remain so unless the CONSULTANT requests and the DIRECTOR approves, in	
8	writing, a change of the CONSULTANT'S PROJECT MANAGER, which approval will not	
9	be unreasonably withheld; and	
10	WHEREAS, said AGREEMENT is subject to 49 Code of Federal Regulations	
11	(hereinafter referred to as "49 CFR"), Part 26 Participation by Disadvantaged Business	
12	Enterprises in Department of Transportation Financial Assistance Programs,	
13	Disadvantaged Business Enterprise programs established by other federal agencies and/or	
14	the COUNTY'S Disadvantaged Business Enterprise Program (all of which are hereinafter	
15	referred to as "DBE PROGRAM(S)"),	
16	NOW, THEREFORE, in consideration of the promises and covenants set forth	
17	herein, the above named parties agree as follows:	
18	I. GENERAL PROVISIONS	
19	A. The COUNTY hereby contracts with the CONSULTANT as an independent	
20	contractor to provide all consultant engineering services required for the PROJECT(S).	
21	Said services are described generally in Article II and more specifically enumerated in	
22	Article III herein.	
23	B. The CONSULTANT'S services shall be performed as expeditiously as is	
24	consistent with professional skill and the orderly progress of the work, based on schedules	
25	for each specific PROJECT mutually agreed upon in advance by the CONTRACT	
26	ADMINISTRATOR, and the CONSULTANT, and consistent with schedules established	
27	under Article V.	
28	C. The CONSULTANT'S PROJECT team staff shall be as listed in Appendix A,	

attached hereto and incorporated herein. Any substitutions of personnel must be approved
in advance by the CONTRACT ADMINISTRATOR, which approval shall not be
unreasonably withheld. The CONSULTANT shall notify the CONTRACT ADMINISTRATOR
of the names and classifications of employees assigned to each specific PROJECT, and
shall not reassign such employees to other projects of the CONSULTANT without
notification to and prior approval by the CONTRACT ADMINISTRATOR.

D. The CONSULTANT may retain, as subconsultants, specialists in such 7 engineering disciplines (including, but not limited to, structural, mechanical, transportation, 8 9 environmental, water resources, electrical, surveying and geotechnical) as the CONSULTANT requires to assist in completing the work. All subconsultants used by the 10 CONSULTANT shall be approved in writing by the CONTRACT ADMINISTRATOR before 11 they are retained by the CONSULTANT, which approval shall not be unreasonably 12 withheld. The subconsultants listed in Appendix B, attached hereto and incorporated 13 herein, shall be considered as approved by the CONTRACT ADMINISTRATOR. Should 14 the CONSULTANT retain any subconsultants, the maximum amount of compensation to 15 be paid to the CONSULTANT under Article VI below shall not be increased. Any additional 16 compensation to be paid to the CONSULTANT for such subconsultants' work shall be 17 limited to administrative time as defined in the fee proposal. Additional fees other than 18 those defined in the fee proposal shall not be reimbursed. 19

E. The CONSULTANT and affiliated subconsultants shall not submit bids, or sub-20 bids, for the contract construction phase of the PROJECT(S) assigned to the 21 CONSULTANT. The CONSULTANT and its subconsultants, and all other service 22 providers, shall not provide any PROJECT-related services for, or receive any PROJECT-23 related compensation from any construction contractor, subcontractor or service provider 24 awarded a construction contract (hereinafter referred to as "contractor") for all or any 25 portion of the PROJECT(S) for which the CONSULTANT provides services hereunder. 26 The CONSULTANT and its subconsultants, and all other service providers, may provide 27 services for, and receive compensation from a contractor who has been awarded a 28

construction contract for all or any portion of the PROJECT(S), provided that any such
 services which are rendered, and any compensation which is received therefor, relates to
 work outside the scope of the AGREEMENT and does not pose a conflict of interest.

F. Any subcontract in excess of \$25,000 entered into as a result of the
 AGREEMENT, shall contain all the provisions stipulated in the AGREEMENT to be
 applicable to subcontractors.

G. The CONSULTANT is responsible for being fully informed regarding the
 requirements of 49 CFR, Part 26 and the CALTRANS Disadvantaged Business Enterprise
 program developed pursuant to the regulations, as detailed in Appendix C, attached hereto
 and incorporated herein.

II. DESCRIPTION OF THE WORK COVERED BY THE AGREEMENT

A. The work to be performed by the CONSULTANT under the AGREEMENT 12 includes on-call professional services under Article III for various COUNTY Public Works 13 PROJECTS, including but not limited to, general civil and transportation engineering, 14 structural engineering, geotechnical engineering and materials testing, water resources 15 engineering, electrical and control systems engineering, and surveying. Work on roads 16 and bridges shall be done in accordance with American Association of State Highway and 17 Transportation Officials (AASHTO) requirements for applicable structures. All projects 18 funded wholly or in part by CALTRANS must conform to all requirements by CALTRANS 19 and Federal Highway Administration (FHWA) as contained in Section 11 of CALTRANS 20 LAPM Volume 1. 21

B. The CONSULTANT agrees to provide the professional services that are
 necessary for each PROJECT when expressly authorized in writing by the CONTRACT
 ADMINISTRATOR. Such work by the CONSULTANT shall not begin until the
 CONSULTANT has received a written Notice to Proceed from the CONTRACT
 ADMINISTRATOR authorizing the necessary service, agreed upon fee, and scope of work.
 <u>III. CONSULTANT'S SERVICES</u>

The CONSULTANT shall submit proposals in response to requests issued by the

CONTRACT ADMINISTRATOR on a project-by-project basis. The CONSULTANT'S 1 proposal at a minimum shall include, but not be limited to, staff qualifications, proposed 2 method and schedule for completing the task(s), completed federal forms and a sealed 3 cost proposal. The CONSULTANT agrees that each professional or other individual 4 performing work on any such PROJECT(S) shall be adequately trained to perform the work 5 and shall possess the proper license, certification or registration as required by law or by 6 accepted standards of the applicable profession. The CONSULTANT agrees to provide 7 the professional services that are necessary to complete the following tasks when 8 expressly authorized in writing by the CONTRACT ADMINISTRATOR: 9 A. Technical Reports: 10 1. Ascertain the requirements for Technical Reports through meetings with 11 the CONTRACT ADMINISTRATOR and a review of existing information on the 12 PROJECT(S). 13 2. The CONSULTANT shall prepare and submit technical reports to the 14 CONTRACT ADMINISTRATOR for each assigned PROJECT. Technical reports shall be 15 prepared in accordance with the appropriate format required by local, state and federal 16 laws, regulations and guidelines. 17 3. When requested by the CONTRACT ADMINISTRATOR, the 18 CONSULTANT shall attend meetings with the COUNTY, federal, state and/or local 19 representatives to discuss and review the technical report. The CONSULTANT shall 20 prepare brief minutes of meetings attended and promptly submit the minutes to the 21 CONTRACT ADMINISTRATOR within seven (7) days. 22 The CONSULTANT shall submit each technical report to the CONTRACT 23 ADMINISTRATOR for transmittal to other appropriate agencies for their review and 24 approval. The CONSULTANT shall revise and resubmit each technical report as 25 necessary until approved by all appropriate agencies. Standard submittal shall be five (5) 26 reproducible copies and one (1) electronic copy of each technical report. The 27 CONSULTANT shall verify compatible format and quantity prior to final delivery. 28

1	5. The CONSULTANT shall prepare technical studies and estimates on 8 $\frac{1}{2}$ "
2	by 11" pages, provide hard copy and electronic format as standard submittal; and prepare
3	documents in Microsoft Word 2010 or later, Microsoft Excel 2010 or later, or Adobe 9.0 or
4	later, or other mutually agreed upon format. Such submittals shall be furnished on
5	compact disc (CD). The CONSULTANT shall verify compatible format and quantity prior to
6	final delivery.
7	6. The CONSULTANT shall submit five (5) hard copies of each drawing
8	prepared with AutoCAD Civil 3D, version 2013 or later and an electronic copy in the form of
9	.DXF or .DWG files. Such submittals shall be furnished on CD. The CONSULTANT shall
10	verify a compatible format prior to final file delivery.
11	B. Prepare Design Plans, Technical Specifications and Construction Estimate:
12	The CONSULTANT shall:
13	1. Ascertain the requirements for the assigned PROJECT(S) through
14	meetings with the CONTRACT ADMINISTRATOR and a review of an existing schematic
15	layout of the PROJECT(S).
16	2. Ascertain any requirements, unforeseen criteria, or issues for the
17	PROJECT(S) that may be unknown to the CONTRACT ADMINISTRATOR and
18	communicate these requirements, criteria, or issues to the CONTRACT ADMINISTRATOR.
19	3. Provide surveying, if needed, for the PROJECT(S).
20	4. Design the PROJECT(S) to conform to requirements of the reviewing
21	agencies having jurisdiction over the PROJECT(S).
22	5. Design the PROJECT(S) to include mitigation measures included in the
23	environmental document.
24	6. Monitor and keep the CONTRACT ADMINISTRATOR informed regarding
25	the impact of design issues on the PROJECT budget. Upon the written request of the
26	CONTRACT ADMINISTRATOR, the CONSULTANT shall incorporate into the design, such
27	reasonable design and operational changes as the CONTRACT ADMINISTRATOR deems
28	appropriate as a result of the COUNTY'S review processes and impact on each PROJECT

7. Assist the COUNTY in determining all permits that may be required for the
 PROJECT and prepare all necessary permits for the COUNTY'S submittal to outside
 agencies.

8. Work with the CONTRACT ADMINISTRATOR to ensure that the plans,
 specifications and estimate meet all requirements to be advertised for construction bids.

9. Prepare a detailed estimate, which shall identify the construction
components and requirements of the PROJECT.

9 10. If required by approval agencies, submit to the COUNTY in the
appropriate agency forms, the PROJECT background information and recommended
testing and inspection list for materials to be used, identifying type, quantity, frequency, and
schedule, for each PROJECT. Submit required numbers of sets of plans, specifications,
and other documents required by approval agencies to the CONTRACT
ADMINISTRATOR.

11. Prepare technical specifications and estimate setting forth in detail the
work to be done, the materials, workmanship, and equipment required for the other
components of construction necessary to provide the COUNTY complete and functional
the PROJECTS for its intended purpose within the requirements of the AGREEMENT.

19 12. Assist the CONTRACT ADMINISTRATOR in developing base bid and 20 additive bid item schedules.

13. Submit to the CONTRACT ADMINISTRATOR the projected and final
 construction estimate. Verify the reasonableness of the estimated construction period for
 construction contract bidding purposes as provided by the CONTRACT ADMINISTRATOR
 and identify long delivery times of materials and equipment which will control length of
 construction contract.

14. Respond to Requests for Clarification during the bidding process and
 submit to the CONTRACT ADMINISTRATOR for review and approval any additional
 specifications, clarifications, or additional plan sheets deemed necessary. Responses

1 || should be submitted within three (3) working days of receipt.

15. Assist the CONTRACT ADMINISTRATOR in evaluating the bids
 received.

16. Delete or otherwise change portions of the construction work at the 4 request of the CONTRACT ADMINISTRATOR if the lowest bid proposal for the 5 construction contract exceeds the COUNTY approved engineer's estimate (which will 6 include the CONSULTANT'S design contingency amount approved by the COUNTY) by 7 10% or more; and if the COUNTY rejects all bids, modifications performed by the 8 CONSULTANT shall be completed on a time schedule commensurate with the scope of 9 the changes and as set forth by the COUNTY, and the CONSULTANT will be 10 compensated on a time and materials basis, as agreed to in writing, by the COUNTY and 11 the CONSULTANT. 12

17. Submit to the CONTRACT ADMINISTRATOR ten (10) copies of the 13 30%, 60% and 90% plans (22" X 34" format), specifications and estimates for review. 14 Submit progress prints and final originals of the plans, specifications, and estimates. Prior 15 to submission of plans, the CONSULTANT shall request from the CONTRACT 16 ADMINISTRATOR examples of acceptable drafting format and reproducible standards. 17 Verification of compatible format will be required prior to final file delivery. The CONTRACT 18 ADMINISTRATOR, at his/her discretion, may reject a submittal that is determined 19 insufficient. 20

a. 30% plans, specifications and estimates shall include copies of
 utility locations, centerline stationing, proposed and existing right-of-way, typical sections
 and structural sections.

b. 60% plans, specifications and estimates shall include 30% plan
information and in addition, preliminary cross sections and earthwork calculations at 25' or
50' intervals, adequate information to allow construction survey staking, permits,
preliminary profile grade, an updated engineer's estimate, and also shall address
comments and include necessary revisions as identified by the CONTRACT

2	c. 90% plans, specifications and estimates shall include 60% plan	
3	information and in addition, updated cross sections and earthwork, profile grade, technical	
4	specifications, typical sections and the PROJECT details, and also shall address	
5	comments and include necessary revisions as identified by the CONTRACT	
6	ADMINISTRATOR in the 60% review.	
7	d. Final original plans, specifications and estimates to be delivered to	
8	the CONTRACT ADMINISTRATOR shall include:	
9	i. One (1) original reproducible plan set on 22" by 34" sheets of	
10	4 mil thick double matte film.	
11	ii. One (1) reproducible copy of cross sections on 22" by 34"	
12	sheets of 4 mil thick double matte film.	
13	iii. One (1) CD or DVD with final plans, cross sections and	
14	slope stake information, design calculations, quantity calculations, and other design	
15	information as applicable to the PROJECT.	
16	iv. One (1) stamped and wet signed paper copy and one (1) CD	
17	or DVD with final specifications and estimates.	
18	18. Plan sheets, cross sections, earthwork calculations and slope stake	
19	information shall be in AutoCAD Civil 3D, version 2013 or later. Slope stake information	
20	shall include 50-foot intervals for tangent sections and 25-foot intervals for curved sections.	
21	Specifications shall be in Microsoft Word, version 2010 or later and on 8 ½" by 11" pages.	
22	Final engineer's estimates shall be in Microsoft Excel, version 2010 or later and on 8 1/2" by	
23	11" pages. Estimates shall specify specialty and/or final pay items as described in the	
24	CALTRANS State Standard Specifications. Verification of compatible format will be	
25	required prior to final file delivery.	
26	19. The COUNTY will package the CONSULTANT'S documents with those	
27	other documents that together will comprise the COUNTY'S construction contract and bid	
28	specifications.

20. The CONSULTANT shall deliver to the CONTRACT ADMINISTRATOR 1 three (3) weeks prior to the advertising date (which will be determined by the CONTRACT 2 ADMINISTRATOR) the final completed original drawings and specifications for the 3 COUNTY'S printing and distribution of bid sets to interested prospective contractors. The 4 original drawings and specifications index sheet shall be stamped by a seal with the 5 CONSULTANT'S and subconsultant's license numbers and license renewal dates and/or 6 signed in accordance with the California Business and Professions Code. 7 C. Construction Observation Services: 8 The CONSULTANT shall: 9 1. Attend the preconstruction conference scheduled by the CONTRACT 10 ADMINISTRATOR. 11 2. When requested by the CONTRACT ADMINISTRATOR, attend meetings 12 with the COUNTY, and/or any federal, state and/or local representatives. The 13 CONSULTANT shall prepare brief minutes of all meetings attended and promptly submit 14 those minutes to the CONTRACT ADMINISTRATOR within seven (7) calendar days. 15 3. Make recommendations to the COUNTY on all claims of the COUNTY or 16 the construction contractor and all other matters relating to the execution and progress of 17 work, including interpretation of the contract documents for the PROJECT. 18 4. Within seven (7) calendar days of the COUNTY'S request, review and 19 make recommendations for samples, schedules, shop drawings, and other submissions for 20 general conformance with the design concept of the PROJECT(S) and for general 21 compliance with the plans and specifications and information provided by the contract 22 documents for the PROJECT. 23 5. Within two (2) working days, respond to requests from the CONTRACT 24 ADMINISTRATOR for information needed from the CONSULTANT in order to clarify 25 construction plans and specifications and to review the construction contractor's cost 26 estimates for all change orders. 27 6. Recommend and assist in the preparation of such change orders as 28

deemed necessary with supporting documentation, calculations and estimate, for review
 and issuance of change orders by the COUNTY Construction Engineer to obtain
 appropriate agency acceptance and approval.

7. Assist the COUNTY, at the DIRECTOR's express, written authorization, 4 with any claim resolution process involving the construction contractor and the COUNTY as 5 specified hereunder, including serving as a witness in connection with any public hearings 6 or legal proceeding, and also including dispute resolutions required by law or hereunder. 7 The parties recognize that this clause is provided as a means of expediting resolution of 8 claims among the construction contractor, the COUNTY, and the CONSULTANT. 9 However, it is understood the construction contractor is not an intended third party 10 beneficiary of this clause. Compensation for these services shall be computed and 11 invoiced at hourly rates listed in Appendix D hereto. Any assistance provided by the 12 CONSULTANT as described in this Article III, Section C, Paragraph 7 shall be subject to 13 14 the provisions of Article VI, hereinafter, and shall also be subject to the following:

a. The DIRECTOR may believe the CONSULTANT'S work under the 15 AGREEMENT to have included negligent errors or omissions, or that the CONSULTANT 16 may otherwise have failed to comply with the provisions of the AGREEMENT, either 17 generally or in connection with its duties as associated with a particular PROJECT; and 18 that the cause(s) for a claim by the construction contractor may be attributable, in whole or 19 in part, to such conduct on the part of the CONSULTANT. Upon notice by the DIRECTOR, 20 the payments to the CONSULTANT for such arguably deficient services shall be held in 21 suspense by the COUNTY until a final determination has been made, of the proportion that 22 the CONSULTANT'S fault bears to the fault of all other parties concerned. 23

b. Such amounts held in suspense shall not be paid to the
CONSULTANT, pending the final determination as to the CONSULTANT'S proportional
fault. However, the appropriate percentage of such amount held in suspense shall be paid
to the CONSULTANT, once a final determination has been made, and the CONSULTANT
thereafter submits a proper invoice to the COUNTY. Payment shall be issued in

accordance with the procedure outlined in Article VI, Section B, Paragraph 2. 1

8. At intervals appropriate to the stage of construction, or as otherwise 2 deemed necessary by the CONSULTANT, visit the site of the PROJECT(S) as necessary 3 to become familiar generally with the progress and quality of the work and to determine 4 whether the work is proceeding in general accordance with the contract documents. The 5 CONSULTANT shall not be required to make exhaustive or continuous onsite inspections 6 but shall give direction to the Construction Inspector as hereinafter more specifically 7 8 provided. The CONSULTANT shall not be responsible for the construction contractor's failure to carry out the construction work in accordance with the contract documents. 9 However, the CONSULTANT shall immediately advise the CONTRACT ADMINISTRATOR 10 of any known or observed deviation from the contract documents. 11

9. Not have control over or charge of, and shall not be responsible for construction means, methods, techniques, sequence, or procedure, or for the safety 13 precautions, programs, or equipment in use in connection with the work, since these are 14 solely the construction contractor's responsibility under the contract for construction.

10. Submit progress reports on each specific PROJECT in accordance with 16 the task order. These reports shall be submitted at least once a month. The report shall be 17 sufficiently detailed for CONTRACT ADMINISTRATOR to determine if the CONSULTANT 18 is performing to expectations or is on schedule, to provide communication of interim 19 findings, and so sufficiently address any difficulties or special problems encountered so 20 remedies can be developed. 21

11. Advise the CONTRACT ADMINISTRATOR of defects and deficiencies 22 observed in the work of the construction contractor, and may recommend that the 23 DIRECTOR reject work as failing to conform to the contract documents. 24

12. Conduct site visits and field observations to facilitate recommendations 25 by the CONSULTANT regarding: 26

a. dates of substantial completion.

b. dates of final completion.

2	d. the DIRECTOR'S filing of the Notice of Completion and Issuance of	
3	Final Certificate for payment.	
4	e. other issues which may require site visits.	
5	D. Control of Construction Project Site	
6	The COUNTY agrees that in accordance with generally accepted practices, the	
7	COUNTY'S construction contractor will be required to assume sole and complete	
8	responsibility for job site conditions during the course of construction projects; including	
9	safety of all persons and property, and that this requirement shall be made to apply	
10	continuously during projects and not be limited to normal working hours. The	
11	CONSULTANT shall not have control over or charge of, and shall not be responsible for,	
12	project means, methods, techniques, sequences or procedures, as these are solely the	
13	responsibility of the construction contractor. The CONSULTANT shall not have the	
14	authority to stop or reject the work of the construction contractor.	
15	IV. OBLIGATIONS OF THE COUNTY	
16	The COUNTY will:	
17	A. Issue task orders on a project-by-project basis. Task orders will at a minimum	
18	include scope of work, location, and schedule for the PROJECT.	
19	B. Provide the CONSULTANT with a PROJECT Scope and Schedule, and	
20	compensate the CONSULTANT as provided in the AGREEMENT.	
21	C. Provide an individual CONTRACT ADMINISTRATOR to serve as a	
22	representative of the COUNTY who will coordinate and communicate with the	
23	CONSULTANT, to the extent appropriate, to facilitate the CONSULTANT'S performance of	
24	its obligations in accordance with the provisions of the AGREEMENT.	
25	D. Provide basic plan sheet layouts as required.	
26	E. Examine documents submitted to the COUNTY by the CONSULTANT and timely	
27	render decisions pertaining thereto.	
28	F. Provide aerial photographs as required.

G. Provide copies of any available existing as-built plans and right-of-way drawings from the COUNTY'S files.

H. Provide mailing lists and labels for notification of property owners upon the
 CONSULTANT'S request.

I. Provide preliminary engineering survey data on existing structures and
 topographic mapping in AutoCAD Civil 3D, version 2013 or later, format to the
 CONSULTANT, if available.

J. Prepare all legal descriptions and drawings required for right-of-way acquisition
 and/or temporary construction permits.

K. Provide limited assistance to CONSULTANT, as may be appropriate under the
 circumstances, in connection with CONSULTANT'S processing of required permits.

L. Give reasonably prompt consideration to all matters submitted for approval by
 the CONSULTANT to the end that there will be no substantial delays in the
 CONSULTANT'S program of work. An approval, authorization or request to the
 CONSULTANT given by the COUNTY will be binding upon the COUNTY under the terms
 of the AGREEMENT only if it is made in writing and signed on behalf of the COUNTY by
 CONTRACT ADMINISTRATOR.

V. TERM OF AGREEMENT / PERFORMANCE PERIOD

A. The term of this AGREEMENT shall be for a period of three (3) years, 19 commencing upon execution by the COUNTY, through and including the third anniversary 20 of the execution date. This AGREEMENT may be extended for two additional consecutive 21 twelve-month periods upon written approval of both parties no later than thirty (30) days 22 prior to the first day of the next twelve-month extension period. The DIRECTOR or his or 23 her designee is authorized to execute such written approval on behalf of COUNTY based 24 on CONSULTANT'S satisfactory performance. The CONSULTANT shall commence work 25 promptly after receipt of a notice to proceed issued by the CONTRACT ADMINISTRATOR. 26

B. The CONSULTANT is advised and hereby acknowledges its understanding that any recommendation for award is not binding on the COUNTY until the AGREEMENT is

VI. ALLOWABLE COSTS AND PAYMENTS

A. Total Fee:

Notwithstanding any other provisions in the AGREEMENT, the Total Fee
 for the services required under the AGREEMENT, shall not exceed the total sum of Three
 Hundred Thousand and No/000 Dollars (\$300,000.00) over the entire term of the
 AGREEMENT. Compensation for the services

8 rendered shall be computed at the hourly and cost rates shown in Appendix D, subject to
9 any adjustments that may be approved in accordance with Article VI, Section A, Paragraph
10 3.

2. The hourly and cost rates listed herein for services rendered by the
 CONSULTANT and subconsultants shall remain in effect for the entire duration of the
 AGREEMENT unless adjusted in accordance with the provisions of Article VI, Section A,
 Paragraphs 3, 5, or 6.

3. The hourly rates paid for services performed by the CONSULTANT and by 15 subconsultants of the CONSULTANT and the rates for expenses incidental to the 16 CONSULTANT'S and subconsultant's performance of services may be adjusted no more 17 than once annually for inflation, in accordance with the following provisions: the 18 CONSULTANT may request new labor rates and new rates for expenses incidental to the 19 CONSULTANT'S and subconsultant's performance of services subject to written approval 20 of the CONTRACT ADMINISTRATOR in accordance with the provisions of this Article VI, 21 Section A, Paragraph 3. The CONSULTANT shall initiate the rate adjustment process by 22 submitting to the CONTRACT ADMINISTRATOR a proposed adjusted fee schedule. The 23 proposed adjusted fee schedule shall include proposed hourly rates for all categories of the 24 CONSULTANT and subconsultants wage classifications and proposed rates for incidental 25 expenses listed in Appendix D. The proposed adjusted fee schedule shall not take effect 26 unless approved in writing by the CONTRACT ADMINISTRATOR. The CONSULTANT 27 hereby acknowledges its understanding that approval by the CONTRACT 28

ADMINISTRATOR of any upward adjustment in the hourly and cost rates shall not provide a basis for any increase in the total fee of \$300,000.00, as set forth in Article VI, Section A, Paragraph 1.

4. Expenses incidental to the CONSULTANT'S and subconsultant's 4 performance of services under Article III of the AGREEMENT shall be charged at the rates 5 listed in Appendix D, subject to any adjustments that may be approved in accordance with 6 Article VI, Section A, Paragraphs 3, 5, or 6. Unless incorporated in an adjusted fee 7 schedule approved by the CONTRACT ADMINISTRATOR in accordance with Article VI, 8 Section A, Paragraphs 3, 5, or 6, all other expenses incidental to the CONSULTANT'S and 9 any subconsultant's performance of the services under Article III of the AGREEMENT that 10 are not listed in Appendix D shall be borne by the CONSULTANT. 11

5. In the event that, in accordance with Article I, Section D, the CONTRACT 12 ADMINISTRATOR approves the CONSULTANT to retain additional subconsultants not 13 listed in Appendix B, hourly rates paid for services performed by such additional 14 subconsultants of the CONSULTANT and the rates for expenses incidental to 15 subconsultants performance of services may be adjusted no more than once annually for 16 inflation, in accordance with Article VI, Section A, Paragraph 3. The first annual 17 adjustment of hourly and incidental expense rates for such additional subconsultants shall 18 not be approved prior to one year after the CONTRACT ADMINISTRATOR'S approval of 19 the retention of such additional subconsultant(s) by the CONSULTANT. 20

6. Notwithstanding any other provisions in the AGREEMENT, the
 CONTRACT ADMINISTRATOR may, at any time, authorize in writing the revision of the
 CONSULTANT'S or subconsultant's list of rates for incidental expenses to include
 additional categories of such expenses if, in the opinion of the CONTRACT
 ADMINISTRATOR, such revision is necessary to facilitate the CONSULTANT'S
 performance of the PROJECT(S).

B. Payments:

1. Progress payments will be made by the COUNTY upon receipt of the

CONSULTANT'S monthly invoices and approval by the CONTRACT ADMINISTRATOR
 thereof based on the CONTRACT ADMINISTRATOR'S evaluation of the completion of the
 respective components of the assigned PROJECT. Invoices shall clearly identify the
 Phase and Task of the work, and the date(s) on which the work was performed, and shall
 be submitted with the documentation identified in Article VI, Section B, Paragraph 5.
 Invoices shall be forwarded electronically to: <u>PWPBusinessOffice@co.fresno.ca.us</u>

2. Upon receipt of a proper invoice, the CONTRACT ADMINISTRATOR will
 take a maximum of ten (10) working days to review, approve, and submit it to the COUNTY
 Auditor-Controller/Treasurer-Tax Collector. Unsatisfactory or inaccurate invoices will be
 returned to the CONSULTANT for correction and resubmittal. Payment, less retention, if
 applicable, will be issued to the CONSULTANT within forty (40) calendar days of the date
 the Auditor-Controller/Treasurer-Tax Collector receives the approved invoice.

3. The COUNTY is entitled to withhold a five percent (5%) retention from the
 CONSULTANT'S earned compensation in accordance with the provisions of Article VII of
 the AGREEMENT.

An unresolved dispute over a possible error or omission may cause
 payment of the CONSULTANT fees in the disputed amount to be withheld by the
 COUNTY.

5. Concurrently with the invoices, the CONSULTANT shall certify (through
 copies of issued checks, receipts, or other COUNTY pre-approved documentation) that
 complete payment, less a five percent (5%) retention, except as otherwise specified in
 Article VII, has been made to all subconsultants as provided herein for all previous invoices
 paid by the COUNTY. However, the parties do not intend that the foregoing create in any
 subconsultants or sub-contractor a third party beneficiary status or any third party
 beneficiary rights, and do hereby expressly disclaim any such status or rights.

6. Final invoices, and separate invoices for retentions, shall be submitted to
 CONTRACT ADMINISTRATOR no later than thirty (30) days after the phase is completed.
 Payment for retentions, if any, shall not be made until all services for the phase are

1 completed.

7. In the event the DIRECTOR reduces the scope of the CONSULTANT'S
work under the AGREEMENT for a specific PROJECT (or discontinues a specific
PROJECT), whether due to a deficiency in the appropriation of anticipated funding or
otherwise, the CONSULTANT will be compensated on a pro rata basis for actual work
completed and accepted by the DIRECTOR in accordance with the terms of the
AGREEMENT.

8 VII. RETENTION FROM EARNED COMPENSATION

In addition to any amounts withheld under Article III, the CONSULTANT agrees that 9 the COUNTY, at the discretion of the CONTRACT ADMINISTRATOR, may withhold a five 10 percent (5%) retention from the earned compensation of the CONSULTANT. If the 11 CONTRACT ADMINISTRATOR determines that retention will be withheld for a PROJECT, 12 the CONTRACT ADMINISTRATOR will so state in writing prior to commencement of the 13 PROJECT by the CONSULTANT and will identify the PROJECT-specific prerequisites 14 (such as successful completion of a PROJECT phase, as an example) for the release of 15 retentions. 16

17 VIII. TERMINATION

A. The AGREEMENT may be terminated without cause at any time by the COUNTY upon thirty (30) calendar days' written notice. If the COUNTY terminates the AGREEMENT, the CONSULTANT shall be compensated for services satisfactorily completed to the date of termination based upon the compensation rates and subject to the maximum amounts payable agreed to in Article VI, together with such additional services satisfactorily performed after termination which are expressly authorized by the COUNTY to conclude the work performed to date of termination.

B. If the CONSULTANT purports to terminate the AGREEMENT, or otherwise
refuses to perform pursuant to the AGREEMENT, for reasons other than material breach
by the COUNTY, the CONSULTANT shall reimburse the COUNTY, up to a maximum of
\$10,000 for the actual expense of issuing a Request For Proposal (RFP), engaging a new

consultant, and the new consultant's cost in becoming familiar with the previous
 CONSULTANT'S work. The COUNTY'S entitlement to such reimbursement shall in no
 way be construed as a limitation on other damages that may be recoverable by the
 COUNTY as a result of the CONSULTANT'S termination, in breach of its obligations
 hereunder.

C. The COUNTY may immediately suspend or terminate the AGREEMENT in
 whole or in part, where in the determination of the COUNTY there is:

1. An illegal or improper use of funds;

2. A failure to comply with any term of the AGREEMENT;

3. A substantially incorrect or incomplete report submitted to the COUNTY;

4. Improperly performed service.

D. In no event shall any payment by the COUNTY constitute a waiver by the 12 COUNTY of any breach of the AGREEMENT or any default which may then exist on the 13 part of the CONSULTANT, nor shall such payment impair or prejudice any remedy 14 available to the COUNTY with respect to the breach or default. The DIRECTOR shall have 15 the right to demand of the CONSULTANT the repayment to the COUNTY of any funds 16 disbursed to the CONSULTANT under the AGREEMENT, which, in the judgment of the 17 DIRECTOR and as determined in accordance with the procedures of Article XVI, were not 18 expended in accordance with the terms of the AGREEMENT. The CONSULTANT shall 19 promptly refund any such funds upon demand. 20

E. The terms of the AGREEMENT, and the services to be provided thereunder, are 21 contingent on the approval of funds by the appropriating government agency. Should 22 sufficient funds not be allocated, the services provided may be modified, or the 23 AGREEMENT terminated at any time by giving the CONSULTANT thirty (30) days advance 24 written notice. In the event of termination on the basis of this Paragraph, the 25 CONSULTANT'S entitlement to payment, in accordance with the payment provisions set 26 forth hereinabove, shall apply only to work performed by the CONSULTANT prior to receipt 27 of written notification of such non-allocation of sufficient funding. 28

1	IX. FUNDING REQUIREMENTS
2	A. It is mutually understood between the parties that the AGREEMENT may have
3	been written before ascertaining the availability of funds or appropriation of funds, for the
4	mutual benefit of both parties, in order to avoid program and fiscal delays that would occur
5	if the AGREEMENT were executed after that determination was made.
6	B. The AGREEMENT is subject to any additional restrictions, limitations, conditions,
7	or any legislation enacted by the Congress, State Legislature or County Board of
8	Supervisors that may affect the provisions, terms, or funding of the AGREEMENT in any
9	manner.
10	C. It is mutually agreed that if sufficient funds are not appropriated, the
11	AGREEMENT may be amended to reflect any reduction in funds.
12	D. The COUNTY has the option to void the AGREEMENT under the 30-day
13	cancellation clause, or to amend the AGREEMENT by mutually acceptable modification of
14	its provisions to reflect any reduction of funds.
15	X. CHANGE IN TERMS
16	A. The AGREEMENT may be amended or modified only by mutual written
17	agreement of both parties. Except as provided in Article V, Section A, any such written
18	amendment to the AGREEMENT may be approved on the COUNTY's behalf only by its
19	Board of Supervisors.
20	B. The CONSULTANT shall only commence work covered by an amendment after
21	the amendment has been fully executed and written notification to proceed has been
22	issued by the CONTRACT ADMINISTRATOR.
23	XI. DISADVANTAGED BUSINESS ENTERPRISES (DBE) PARTICIPATION
24	A. The CONSULTANT must give consideration to Disadvantaged Business
25	Enterprise (hereinafter referred to as "DBE") firms as specified in 23 Code of Federal
26	Regulations (hereinafter referred to as "CFR") Section 172.5(b), and in 49 CFR, Part 26.
27	The CONSULTANT must meet the DBE goal established for PROJECTS by using DBEs
28	as subconsultants or document a good faith effort to have met the goal. If a DBE
FRESNO	

subconsultant is unable to perform, the CONSULTANT must make a good faith effort to 1 replace him/her with another DBE subconsultant if the goal is not otherwise met. 2

B. The CONSULTANT is responsible for being fully informed regarding the 3 requirements of Title 49 CFR, Part 26 and CALTRANS' Disadvantaged Business 4 Enterprise program developed pursuant to the regulations, as detailed in Appendix C, 5 Notice to Proposers DBE Information, attached hereto and incorporated herein. 6

C. A DBE subconsultant may be terminated only with written approval by the 7 CONTRACT ADMINISTRATOR and only for reasons specified in 49 CFR Section 26.53(f). 8 Prior to requesting the CONTRACT ADMINISTRATOR consent for the proposed 9 termination, the CONSULTANT must meet the procedural requirements specified in 49 10 CFR Section 26.53(f). 11

XII. COST PRINCIPLES 12

A. The CONSULTANT agrees that the Contract Cost Principles and Procedures, 13 Title 48 CFR, Federal Acquisition Regulations System, Chapter 1, Part 31.000 et seq. (Appendix E), shall be used to determine the allowability of cost for individual items.

B. The CONSULTANT also agrees to comply with federal procedures in 16 accordance with Title 49 CFR, Part 18, Uniform Administrative Requirements for Grants 17 and Cooperative Agreements to State and Local Governments. 18

C. Any costs for which payment has been made to the CONSULTANT that are 19 determined by subsequent audit to be unallowable under 49 CFR Part 18 and 48 CFR, 20 Federal Acquisition Regulations System, Chapter 1, Part 31.000 et seq., are subject to 21 repayment by the CONSULTANT to the COUNTY. 22

XIII. COVENANT AGAINST CONTINGENT FEES

A. The CONSULTANT warrants, by execution of the AGREEMENT, that the 24 CONSULTANT has not employed or retained any company or person, other than a bona 25 fide employee working for the CONSULTANT; to solicit or secure the AGREEMENT; and 26 that CONSULTANT has not paid or agreed to pay any company or person other than a 27 bona fide employee, any fee, commission, percentage, brokerage fee, gift, or any other 28

consideration, contingent upon or resulting from the award or formation of the
AGREEMENT. For breach or violation of this warranty, the COUNTY shall have the right
to annul the AGREEMENT without liability, and to pay only for the value of the work
actually performed by the CONSULTANT, or alternatively in the COUNTY's discretion, to
deduct from the contract price or consideration, or otherwise recover the full amount of
such any such commission, percentage, brokerage fee, gift, contingent fee or similar form
of consideration previously paid by the CONSULTANT.

XIV. RETENTION OF RECORDS/AUDIT

A. For the purpose of determining the sufficiency of the CONSUTLANT'S
performance of the contract (and compliance with Public Contract Code 10115, et seq. and
Title 21, California Code of Regulations, Chapter 21, Section 2500 et seq., when
applicable), the CONSULTANT, subcontractors, and the COUNTY, and each of them, shall
maintain all books, documents, papers, accounting records, and other evidence pertaining
to the performance of the AGREEMENT, including but not limited to, the costs of
administering the AGREEMENT.

B. All parties shall make such materials available at their respective offices at all 16 reasonable times throughout the entirety of the contract term and for three years from the 17 date of final payment under the contract, pursuant to Government Code 8546.7. The state, 18 the State Auditor, the COUNTY, Federal Highway Administration, or any duly authorized 19 representative of the federal government shall have access to any books, records, and 20 documents of the CONSULTANT that are pertinent to the contract for audit, examinations, 21 excerpts, and transactions, and copies thereof shall be furnished if requested. It shall be 22 the responsibility of the CONSULTANT to ensure that all subcontracts in excess of 23 \$25,000 shall contain this provision. 24

C. The CONSULTANT and subconsultants' contracts, including cost proposals and
 indirect cost rates (ICR), are subject to audits or reviews such as, but not limited to, a
 Contract Audit, an Incurred Cost Audit, an ICR Audit, or a certified public accountant (CPA)
 ICR Audit Workpaper Review. If selected for audit or review, the AGREEMENT, cost

proposal and ICR and related workpapers, if applicable, will be reviewed to verify 1 compliance with 48 CFR, Part 31 and other related laws and regulations. In the instances 2 of a CPA ICR Audit Workpaper Review it is the CONSULTANT'S responsibility to ensure 3 federal, state, or local government officials are allowed full access to the CPA's 4 workpapers. The AGREEMENT, cost proposal, and ICR shall be adjusted by the 5 CONSULTANT and approved by the CONTRACT ADMINISTRATOR to conform to the 6 audit or review recommendations. The CONSULTANT agrees that individual terms of costs 7 8 identified in the audit report shall be incorporated into the AGREEMENT by this reference if directed by the COUNTY at its sole discretion. Refusal by the CONSULTANT to 9 incorporate audit or review recommendations, or to ensure that the Federal, State, or local 10 governments have access to CPA workpapers, will be considered a breach of the 11 AGREEMENT terms and cause for termination of the AGREEMENT and disallowance of 12 prior reimbursed costs. 13

XV. AUDIT REVIEW PROCEDURES

A. Any dispute concerning a question of fact arising under an interim or post audit
 of the AGREEMENT that is not disposed of by agreement between the parties, shall be
 reviewed by the COUNTY's Auditor/Controller/Treasurer/Tax-Collector.

B. Not later than 30 days after issuance of the final audit report, the CONSULTANT
 may request a review by the COUNTY's Auditor/Controller/Treasurer/Tax-Collector of
 unresolved audit issues. The request for review will be submitted in writing.

C. Neither the pendency of a dispute nor its consideration by the COUNTY will
 excuse the CONSULTANT from full and timely performance, in accordance with the terms
 of the AGREEMENT.

D. The CONSULTANT and subconsultants' contracts, including cost proposals and indirect cost rates (ICR), are subject to audits or reviews such as, but not limited to, a Contract Audit, an Incurred Cost Audit, an ICR Audit, or a certified public accountant (CPA) ICR Audit Workpaper Review. If selected for audit or review, the contract, cost proposal and ICR and related workpapers, if applicable, will be reviewed to verify compliance with 48

CFR, Part 31 and other related laws and regulations. In the instances of a CPA ICR Audit 1 Workpaper Review it is the CONSULTANT's responsibility to ensure federal, state, or local 2 government officials are allowed full access to the CPA's workpapers. The AGREEMENT, 3 cost proposal, and ICR shall be adjusted by the CONSULTANT and approved by the 4 CONTRACT ADMINISTRATOR to conform to the audit or review recommendations. The 5 CONSULTANT agrees that individual terms of costs identified in the audit report shall be 6 incorporated into the contract by this reference if directed by the COUNTY at its sole 7 8 discretion. Refusal by the CONSULTANT to incorporate audit or review recommendations, or to ensure that the Federal, State, or local governments have access to CPA workpapers, 9 will be considered a breach of contract terms and cause for termination of the 10 AGREEMENT and disallowance of prior reimbursed costs. 11

XVI. ERRORS OR OMISSIONS CLAIMS AND DISPUTES

A. Definitions:

A "Consultant" is a duly licensed Architect or Engineer, or other provider of
 professional services, acting as a business entity (owner, partnership, corporation, joint
 venture or other business association) in accordance with the terms of an agreement with
 the COUNTY.

2. A "Claim" is a demand or assertion by one of the parties seeking, as a 18 matter of right, adjustment or interpretation of contract terms, payment of money, extension 19 of time, change orders, or other relief with respect to the terms of the contract. The term 20 "Claim" also includes other disputes and matters in question between the COUNTY and 21 the CONSULTANT arising out of or relating to the contract. Claims must be made by 22 written notice. The provisions of Government Code section 901, et seq., shall apply to 23 every claim made to the COUNTY. The responsibility to substantiate claims shall rest with 24 the party making the claim. The term "Claim" also includes any allegation of an error or 25 omission by the CONSULTANT. 26

B. In the spirit of cooperation between the COUNTY and the CONSULTANT, the
 following procedures are established in the event of any claim or dispute alleging a

1 || negligent error, act, or omission, of the CONSULTANT.

Claims, disputes or other matters in question between the parties, arising
 out of or relating to the AGREEMENT, shall not be subject to arbitration, but shall be
 subject to the following procedures.

2. The COUNTY and the CONSULTANT shall meet and confer and attempt
 to reach agreement on any dispute, including what damages have occurred, the measure
 of damages and what proportion of damages, if any, shall be paid by either party. The
 parties agree to consult and consider the use of mediation or other form of dispute
 resolution prior to resorting to litigation.

3. If the COUNTY and the CONSULTANT cannot reach agreement under 10 Article XVI, Section B, Paragraph 2, the disputed issues may, upon concurrence by all 11 parties, be submitted to a panel of three (3) for a recommended resolution. The 12 CONSULTANT and the COUNTY shall each select one (1) member of the panel, and the 13 third member shall be selected by the other two panel members. The discovery rights 14 provided by California Code of Civil Procedure for civil proceedings shall be available and 15 enforceable to resolve the disputed issues. Either party requesting this dispute resolution 16 process shall, when invoking the rights to this panel, give to the other party a notice 17 describing the claims, disputes and other matters in question. Prior to twenty (20) working 18 days before the initial meeting of the panel, both parties shall submit all documents such 19 party intends to rely upon to resolve such dispute. If it is determined by the panel that any 20 party has relied on such documentation, but has failed to previously submit such 21 documentation on a timely basis to the other party, the other party shall be entitled to a 20-22 working-day continuance of such initial meeting of the panel. The decision by the panel is 23 not a condition precedent to arbitration, mediation or litigation. 24

4. Upon receipt of the panel's recommended resolution of the disputed
issue(s), the COUNTY and the CONSULTANT shall again meet and confer and attempt to
reach agreement. If the parties still are unable to reach agreement, each party shall have
recourse to all appropriate legal and equitable remedies.

C. The procedures to be followed in the resolution of claims and disputes may be modified any time by mutual agreement of the parties hereto.

D. The CONSULTANT shall continue to perform its obligations under the
AGREEMENT pending resolution of any dispute, and the COUNTY shall continue to make
payments of all undisputed amounts due under the AGREEMENT.

E. When a claim by either party has been made alleging the CONSULTANT'S
negligent error, act, or omission, the COUNTY and the CONSULTANT shall meet and
confer within twenty-one (21) working days after the written notice of the claim has been
provided.

10 XVII. SUBCONTRACTING

A. The CONSULTANT shall perform the work contemplated with resources
 available within its own organization; and no portion of the work pertinent to this contract
 shall be subcontracted without prior written authorization by the CONTRACT
 ADMINISTRATOR, excepting only those portions of the work and the responsible
 subconsultants that are expressly identified in Appendix B hereto.

B. Any subcontract in excess of \$25,000 entered into by CONSULTANT, pertaining
 to work to be performed under the AGREEMENT, shall contain all of the provisions
 stipulated in the AGREEMENT to be applicable to subconsultants.

C. Any substitution of subconsultant(s) must be approved in writing by the CONTRACT ADMINISTRATOR prior to the start of work by such subconsultant(s).

21 XVIII. EQUIPMENT PURCHASE

A. Prior authorization in writing, by the CONTRACT ADMINISTRATOR shall be
 required before the CONSULTANT enters into any unbudgeted purchase order, or
 subcontract exceeding \$5,000 for supplies, equipment, or CONSULTANT services. The
 CONSULTANT shall provide an evaluation of the necessity or desirability of incurring such
 costs.

B. Prior authorization by the CONTRACT ADMINISTRATOR shall be required for
 purchase of any item, service or consulting work in excess of \$5,000 that is not covered in

the CONSULTANT'S Cost Proposal; and the CONSULTANT'S request must be
 accompanied by at least three competitive quotations, unless the absence of bidding is
 adequately justified, to the satisfaction of the CONTRACT ADMINISTRATOR in his or her
 discretion, by written explanation provided by the CONSULTANT with its submittal.

C. Any authorized purchase of equipment as a result of the AGREEMENT is 5 subject to the following: "The CONSULTANT shall maintain an inventory of all 6 nonexpendable property. Nonexpendable property is defined as having a useful life of at 7 8 least two years and an acquisition cost of \$5,000 or more. If the purchased equipment needs replacement and is sold or traded in, the COUNTY shall receive a proper refund or 9 credit at the conclusion of the contract, or if the contract is terminated, the CONSULTANT 10 may either keep the equipment and credit the COUNTY in an amount equal to its fair 11 market value, or sell such equipment at the best price obtainable at a public or private sale, 12 in accordance with established COUNTY procedures; and credit the COUNTY in an 13 amount equal to the sales price. If the CONSULTANT elects to keep the equipment, fair 14 market value shall be determined at the CONSULTANT'S expense, on the basis of a 15 competent independent appraisal of such equipment. Appraisals shall be obtained from an 16 appraiser mutually agreeable to by the COUNTY and the CONSULTANT, if it is determined 17 to sell the equipment, the terms and conditions of such sale must be approved in advance 18 by the COUNTY." Title 49 CFR, Part 18 requires a credit to Federal funds when 19 participating equipment with a fair market value greater than \$5,000.00 is credited to the 20 PROJECT. 21

22 XIX. INSPECTION OF WORK

The CONSULTANT and any subcontractor shall permit the COUNTY, the state, and the FHWA to review and inspect the PROJECT activities and files at all reasonable times during the performance period of the AGREEMENT including review and inspection on a daily basis.

27 XX. LIABILITY INSURANCE

Comprehensive Automobile Liability Insurance with limits for bodily injury 13 of Two Hundred Fifty Thousand Dollars (\$250,000.00) per person, Five Hundred Thousand 14 Dollars (\$500,000.00) per accident and for property damages of Fifty Thousand Dollars 15 (\$50,000.00), or such coverage with a combined single limit of Five Hundred Thousand 16 Dollars (\$500,000.00). Coverage should include owned and non-owned vehicles used in 17 connection with the AGREEMENT. 18

3. Worker's Compensation insurance policy as required by the California 19 Labor Code. 20

21 22 4. Professional Liability Insurance:

a. If the CONSULTANT employs licensed professional staff in providing services, Professional Liability Insurance with limits of One Million Dollars 23 (\$1,000,000.00) per claim, Three Million Dollars (\$3,000,000.00) annual aggregate. 24 b. The Professional Liability Insurance shall be kept in full force and 25 effect for a period of three (3) years from the date of substantial completion of the 26 CONSULTANT'S work as determined by the COUNTY. 27

Prior to commencing any such work under the AGREEMENT, the CONSULTANT shall provide to the COUNTY certificates of insurance and endorsements 10 for all of the required policies as specified above, stating that all such insurance coverage 11 has been obtained and is in full force; that the COUNTY, its officers, agents and 12 employees will not be responsible for any premiums on the policies; that such Commercial 13 General Liability insurance names the COUNTY, its officers, agents and employees, 14 individually and collectively, as additional insured, but only insofar as the operations under 15 the AGREEMENT are concerned; that such coverage for additional insured shall apply as 16 primary insurance and any other insurance, or self-insurance, maintained by the COUNTY, 17 its officers, agents and employees, shall be excess only and not contributing with insurance 18 provided under the CONSULTANT'S policies herein; and that this insurance shall not be 19 cancelled or changed without a minimum of thirty (30) days advance, written notice given 20 to the COUNTY. All certificates shall clearly indicate the COUNTY'S identifying Contract 21 Number for the AGREEMENT, and the certificates shall be sent to the attention of the 22 CONTRACT ADMINISTRATOR. 23

e. In the event the CONSULTANT fails to keep in effect at all times insurance coverage as herein provided, the COUNTY may, in addition to other remedies it may have, suspend or terminate the AGREEMENT upon the occurrence of such event.

27f. All policies shall be issued by admitted insurers licensed to do28business in the State of California, and all such insurance shall be purchased from

1 companies possessing a current A.M. Best, Inc. rating of A and FSC VII or better.

2 XXI. HOLD HARMLESS

A. The CONSULTANT shall defend, hold harmless and indemnify the COUNTY, its officers, agents, and employees, against the payment of any and all costs and expenses (including reasonable attorney fees and court costs), damages, claims, suits, losses, and liability for bodily and personal injury to or death of any person or for loss of any property resulting from or arising out of any negligent or wrongful acts, errors or omissions of the CONSULTANT, its officers, agents, and employees, in performing or failing to perform any work, services, or functions under the AGREEMENT.

B. The COUNTY and the CONSULTANT hereby declare their mutual intent to
 cooperate in the defense of any claim, suit, or other action alleging liability, arising from the
 negligent performance or failure to perform of any COUNTY construction contractor or
 subcontractor involved in PROJECT(S). Such cooperation may include an agreement to
 prepare and present a cooperative defense after consultation with the CONSULTANT'S
 professional liability insurance carrier.

XXII. OWNERSHIP OF DATA

A. All documents, including preliminary documents, calculations, and survey data,
 required in performing services under the AGREEMENT shall be submitted to, and shall
 remain at all times the property of the COUNTY regardless of whether they are in the
 possession of the CONSULTANT or any other person, firm, corporation or agency.

B. The CONSULTANT understands and agrees the COUNTY shall retain full 21 ownership rights of the drawings and work product of the CONSULTANT for the 22 PROJECT, to the fullest extent permitted by law. In this regard, the CONSULTANT 23 acknowledges and agrees the CONSULTANT'S services are on behalf of the COUNTY 24 and are "works made for hire," as that term is defined in copyright law, by the COUNTY; 25 that the drawings and work product to be prepared by the CONSULTANT are for the sole 26 and exclusive use of the COUNTY, and that the COUNTY shall be the sole owner of all 27 patents, copyrights, trademarks, trade secrets and other rights and contractual interests in 28

connection therewith which are developed and compensated solely under the 1 AGREEMENT; that all the rights, title and interest in and to the drawings and work product 2 will be transferred to the COUNTY by the CONSULTANT to the extent the CONSULTANT 3 has an interest in and authority to convey such rights; and the CONSULTANT will assist 4 the COUNTY to obtain and enforce patents, copyrights, trademarks, trade secrets, and 5 other rights and contractual interests relating to said drawings and work product, free and 6 clear of any claim by the CONSULTANT or anyone claiming any right through the 7 CONSULTANT. The CONSULTANT further acknowledges and agrees the COUNTY's 8 ownership rights in such drawings or work product, shall apply regardless of whether such 9 drawings or work product, or any copies thereof, are in possession of the CONSULTANT, 10 or any other person, firm, corporation, or entity. For purposes of the AGREEMENT the 11 terms "drawings and work product" shall mean all reports and study findings commissioned 12 to develop the PROJECT design, drawings and schematic or preliminary design 13 documents, certified reproducibles of the original final construction contract drawings, 14 specifications, the approved estimate, record drawings, as-built plans, and discoveries, 15 developments, designs, improvement, inventions, formulas, processes, techniques, or 16 specific know-how and data generated or conceived or reduced to practice or learning by 17 the CONSULTANT, either alone or jointly with others, that result from the tasks assigned to 18 the CONSULTANT by the COUNTY under the AGREEMENT. 19

C. If the AGREEMENT is terminated during or at the completion of any phase
 under Article III, a reproducible copy of report(s) or preliminary documents shall be
 submitted by the CONSULTANT to the COUNTY, which may use them to complete the
 PROJECT(S) at a future time.

D. If the PROJECT is terminated at the completion of a construction document phase of the PROJECT, certified reproducibles on 4 mil thick double matte film of the original final construction contract drawings, specifications, and approved engineer's estimate shall be submitted by the CONSULTANT to the COUNTY.

CONSULTANT pursuant to the AGREEMENT are intended to be suitable for reuse by the

 documents will be at the COUNTY'S sole risk and without liability or legal exposure to the
 CONSULTANT.

The electronic files provided by the CONSULTANT to the COUNTY are submitted
for an acceptance period lasting until the expiration of the AGREEMENT (i.e., throughout
the duration of the contract term, including any extensions). Any defects the COUNTY
discovers during such acceptance period will be reported to the CONSULTANT and will be
corrected as part of the CONSULTANT'S "Basic Scope of Work."

F. The CONSULTANT shall not be liable for claims, liabilities or losses arising out 11 of, or connected with (1) the modification or misuse by the COUNTY or anyone authorized 12 by the COUNTY, of such CAD data, or (2) decline of accuracy or readability of CAD data 13 due to inappropriate storage conditions or duration; or (3) any use by the COUNTY, or 14 anyone authorized by the COUNTY, of such CAD data or other PROJECT documentation 15 for additions to the PROJECT for the completion of the PROJECT by others, or for other 16 projects; except to the extent that said use may be expressly authorized, in writing, by the 17 CONSULTANT. 18

G. The COUNTY, in the discretion of its Board of Supervisors, may permit the
copyrighting of reports or other products of the AGREEMENT; and provided further, that if
copyrights are permitted; the CONSULTANT hereby agrees and the AGREEMENT shall be
deemed to provide that the Federal Highway Administration shall have the royalty-free
nonexclusive and irrevocable right to reproduce, publish, or otherwise use, and to authorize
others to use, the work for government purposes.

XXIII. CLAIMS FILED BY THE COUNTY'S CONSTRUCTION CONTRACTOR

A. If claims are filed by the COUNTY's construction contractor relating to work performed by the CONSULTANT'S personnel, and additional information or assistance from the CONSULTANT'S personnel is required in order to evaluate or defend against

such claims, then the CONSULTANT hereby agrees in such event to make its personnel
 available for consultation with the COUNTY's construction contract administration and legal
 staff and for testimony, if necessary, at depositions and at trial or arbitration proceedings.

B. The CONSULTANT'S personnel that the COUNTY considers essential to assist
in defending against the construction contractor's claims will be made available on
reasonable notice from the DIRECTOR. Services of the CONSULTANT'S personnel in
connection with consultation or testimony for this purpose will be performed pursuant to a
written contract amendment, if determined by the parties to be necessary or appropriate.
XXIV. CONFIDENTIALITY OF DATA

A. All financial, statistical, personal, technical, or other data and information relative to the COUNTY'S operations, which are designated confidential by the COUNTY and made available to the CONSULTANT in order to carry out the AGREEMENT, shall be protected by the CONSULTANT from unauthorized use and disclosure.

B. Permission to disclose information on one occasion, or public hearing held by
 the COUNTY relating to the contract, shall not authorize the CONSULTANT to further
 disclose such information, or disseminate the same on any other occasion.

C. The CONSULTANT shall not comment publicly to the press or any other media
 regarding the AGREEMENT or the COUNTY's actions on the same, except to the
 COUNTY's staff, the CONSULTANT'S own personnel involved in the performance of the
 AGREEMENT, at public hearings or in response to questions from a Legislative committee.

D. The CONSULTANT shall not issue any news release or public relations item of
 any nature, whatsoever, regarding work performed or to be performed under the
 AGREEMENT without prior review of the contents thereof by the COUNTY, and receipt of
 the COUNTY'S written permission.

E. All information related to the construction estimate is confidential, and shall not be disclosed by the CONSULTANT to any entity other than the COUNTY.

27 XXV. NATIONAL LABOR RELATIONS BOARD CERTIFICATION

The CONSULTANT hereby certifies that neither the CONSULTANT, nor any firm 21 affiliated with the CONSULTANT will bid on any construction contract, or on any contract to 22 provide construction inspection for any construction PROJECT resulting from the 23 AGREEMENT; provided, however, that this shall not be construed as disallowing the 24 CONSULTANT or affiliated firm from performing, pursuant to the AGREEMENT or other 25 agreement with the COUNTY, construction inspection services on behalf of the COUNTY 26 for the PROJECT. An affiliated firm is one, which is subject to the control of the same 27 persons through joint ownership, or otherwise. 28

E. In the event of any inconsistency in interpreting the documents which constitute the
AGREEMENT, the inconsistency shall be resolved by giving precedence in the following
order of priority: (1) the text of the AGREEMENT (excluding Appendices); (2) Appendices

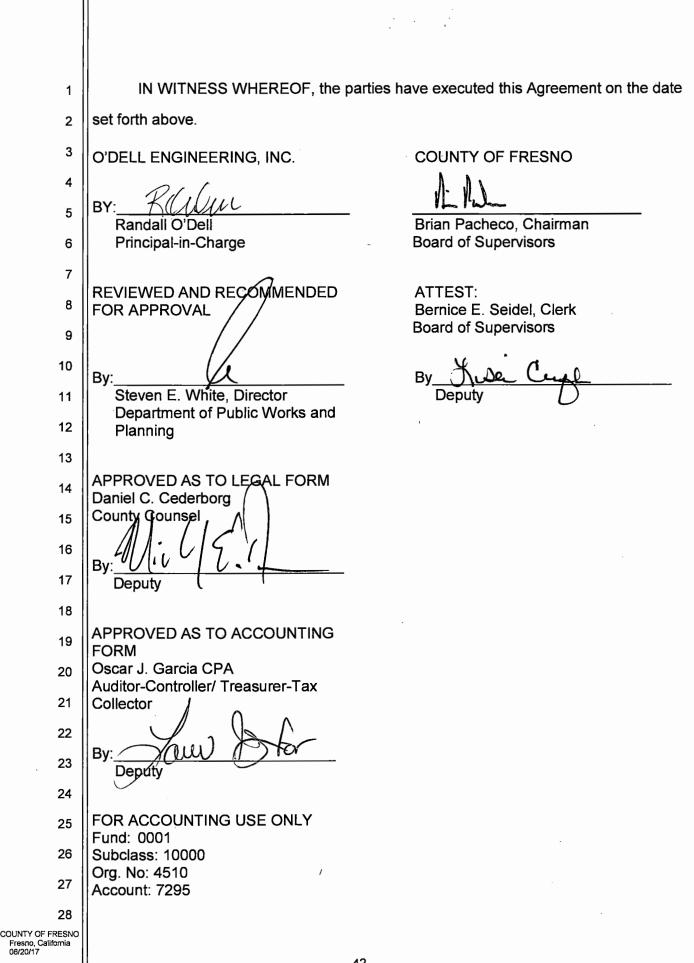

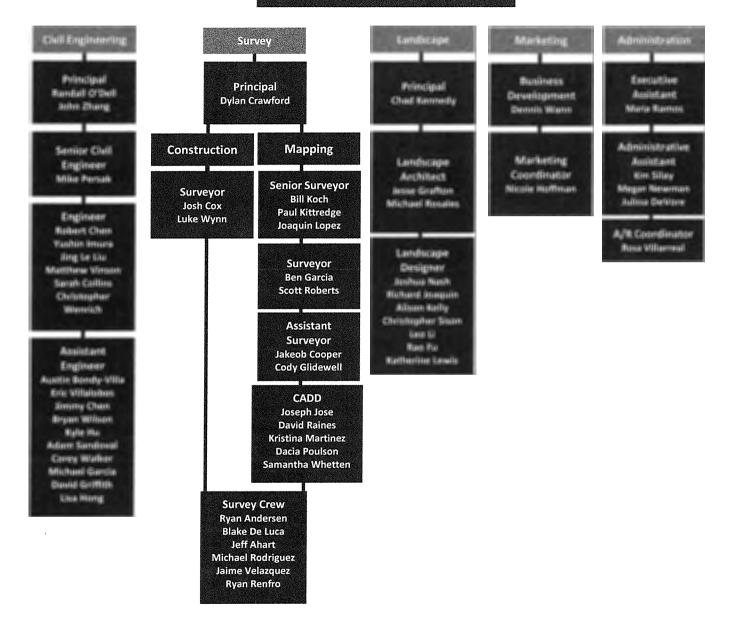
