Thank you so much in advance for your help in regards to the proposed TEFRA Hearing for Omni Family Health ("OFH")! As you know, OFH requested that the California Municipal Finance Authority ("CMFA") serve as the municipal issuer of tax exempt bonds in an amount not to exceed \$15,000,000, (the "Bonds"), to assist in the financing or refinancing of the acquisition, construction, improvement, renovation and equipping of health care facilities located throughout the County of Fresno.

Thank you so much for your help in regards to the proposed Omni Family Health financing! As you know, Omni Family Health submitted an application to the CMFA to be its Issuer of tax-exempt financing for a project located in the County of Fresno. The project is expected to be financed in amount not to exceed \$15,000,000 of tax-exempt revenue bonds. The proceeds of the Bonds will be used to finance the renovation and expansion of a medical facility located at 4646 North First Street, in the City of Fresno and to finance the renovation and expansion of a facility located at 1530 East Manning Avenue, Reedley, California.
