RESOLUTION

WHEREAS, Assembly Bill 109 (Chapter 15, Statutes of 2011) Public Safety Realignment funds are available in the amount of \$765,310 to add five Deputy Sheriff III positions, associated services and supplies, and five vehicles to the Sheriff-Coroner's Org 3111; and

WHEREAS, the Sheriff-Coroner's Org 3111 will receive these funds as an Operating Transfer In from the Special Revenue Fund, Local Community Corrections Org 3436 to fund these expenditures; and

WHEREAS, \$765,310 is not included in the appropriations and estimated revenues of the Sheriff-Coroner's Org 3111 for FY 2017-18; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector be authorized to increase the appropriations in the FY 2017-18 Sheriff-Coroner's Org 3111 as follows:




