WHEREAS, Assembly Bill 109 (Chapter 15, Statutes of 2011) Public Safety  
Realignment funds are available to provide additional funding to expand the Multi-Agency Gang  
Enforcement Consortium; and

WHEREAS, the Probation Organization 3430 will receive \$968,984 as an Operating  
Transfer In from the Special Revenue Fund, Local Community Corrections Org 3436 to fund  
these expenditures; and

WHEREAS, said monies are not included in the adopted FY 2017-18 appropriations and  
estimated revenues for the Probation Organization 3430; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of  
these funds by a four-fifths (4/5<sup>th</sup>) vote of the Board of Supervisors.


NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector


