 OF \$3,194,310 )

WHEREAS, there is available fund balance in the Local Revenue Fund 2011 to fund services associated with AB 109 in the amount of \$3,194,310 for FY 2017-18; and

WHEREAS, the Local Community Corrections Organization 3436 requires an increase in appropriations in the amount of \$3,194,310 to fund an Operating Transfer Out to the District Attorney Organization 2860 (\$805,923), Public Defender Organization 2880 (\$654,093), Sheriff-Coroner Organization 3111 (\$765,310), and Probation Organization 3430 (\$968,984); and

WHEREAS, \$3,194,310 is available in the fund balance of the Local Revenue Fund 2011 Fund 0271, Subclass 13020, to fund these expenditures; and

WHEREAS, said monies are not included in the adopted FY 2017-18 appropriations for the Local Community Corrections 3436; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5<sup>th</sup>) vote of the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Local Community Corrections Organization 3436 as follows:
