## 1 BEFORE THE BOARD OF SUPERVISORS 2 OF THE 3 COUNTY OF FRESNO, STATE OF CALIFORNIA 4 IN THE MATTER OF INCREASING THE FY 2017-18 5 APPROPRIATIONS FOR THE LOCAL COMMUNITY CORRECTIONS ORGANIZATION 3436 IN THE AMOUNT RESOLUTION 6 OF \$3,194,310 7 8 WHEREAS, there is available fund balance in the Local Revenue Fund 2011 to fund services associated with AB 109 in the amount of \$3,194,310 for FY 2017-18; and 9 WHEREAS, the Local Community Corrections Organization 3436 requires an increase in 10 appropriations in the amount of \$3,194,310 to fund an Operating Transfer Out to the District 11 Attorney Organization 2860 (\$805,923), Public Defender Organization 2880 (\$654,093), 12 Sheriff-Coroner Organization 3111 (\$765,310), and Probation Organization 3430 (\$968,984); 13 and 14 WHEREAS, \$3,194,310 is available in the fund balance of the Local Revenue Fund 2011 15 Fund 0271, Subclass 13020, to fund these expenditures; and 16 WHEREAS, said monies are not included in the adopted FY 2017-18 appropriations for 17 the Local Community Corrections 3436; and 18 WHEREAS, Section 29130 of the Government Code provides for the appropriation of 19 these funds by a four-fifths (4/5th) vote of the Board of Supervisors. 20 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector 21 is authorized to increase the appropriations in the FY 2017-18 Local Community Corrections 22 Organization 3436 as follows: 23 **FUND** 0271 Local Revenue Fund 2011 24 SUBCLASS 13020 ORGANIZATION 3436 **Local Community Corrections** 25 26 7900-Other Financing Uses 27 ACCOUNT NO. **Operating Transfers Out** 7910 \$3,194,310 28
