RESOLUTION

WHEREAS, the District Attorney Org 2860 has funds available for the purchase of two investigator vehicles for use in the Misdemeanor Offender Accountability and Rehabilitation program; and

Whereas, the Public Defender Org 2880 also has funds available for the purchase one investigator vehicle for use in the Misdemeanor Offender Accountability and Rehabilitation program; and

WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$60,000 as an Operating Transfer In from the District Attorney Org 2860 to purchase two vehicles; and \$21,000 from the Public Defender Org 2880 to purchase one vehicle; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2017-18 ISD, Fleet Services-Equipment Org 8911 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 ISD, Fleet Services-Equipment Org 8911 as follows:


