WHEREAS, the Department of Social Services requires \$1,745,159 to meet expenditures associated with the new Lease space; and

WHEREAS, the Social Services Fund 0065, Subclass 17225, Welfare Advance Fund Organization 1120 will receive funding from the State and Federal government in the amount \$1,745,159 in FY 2017-18; and

WHEREAS, \$1,745,159 is not included in the FY 2017-18 adopted appropriations and estimated revenues of the Welfare Advance Fund Organization 1120 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Welfare Advance Fund Organization 1120 as follows:


