WHEREAS, the prior year Community Recidivism Reduction Grants (CRRG) Org 3451 includes unexpended 2014 CRRG funds that may be used to fund other CRRG activities; and

WHEREAS, \$10,254 in unexpended 2014 CRRG funds will revert back to the state General Fund if not utilized by June 30, 2018; and

WHEREAS, \$10,254 is available in the fund balance of the Spec Hand Segregated Gen Funds Fund 0009, Subclass 10023 to fund these expenditures; and

WHEREAS, said monies were not included in the adopted appropriations of the FY 2017-18 CRRG Org 3451; and

WHEREAS, Section 29130 of the Governmental Code provides for the appropriation of these funds by a 4/5ths vote of the Board of Supervisors;

NOW, THEREFORE IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 CRRG Org 3451 as follows:


