On September 26, 2017, the Fresno
County Board of Supervisors (the
"Board") adopted ordinance No.17015 authorizing, the annual levying
of a special tax within Community
Facilities District No. 2006-01 (Police
Protection Services) of the County of
Fresno (Mello-Roos / Tentative Tract
No. 4968 ("Annexation Territory"),
commencing County Fiscal Year 201718 (Cal. Gov. Code, secs. 53328,
53340). The special tax shall annually
pay for the cost of County Sheriff
"police protection services" within the
Annexation Territory, and certain related
administrative costs of the Community
Facilities District No. 2006-01 (Police
Protection Services) of the County of
Fresno. The initial maximum special
tax rates for the District are:

Land Use Class Description, Maximum Special Tax Per Unit

Residential Property, \$691.27 per unit Multi-Family Property, \$519.99 per unit

The maximum special tax rates thereafter shall be annually increased for each County fiscal year in accordance with this Ordinance.
