The WAC also evaluated issues that related to groundwater storage and 14 recharge to maintain or increase the water supply in Fresno County; and 15 WHEREAS, the WAC was active for many years following its creation, however, it has not 16 formally met since 2015, due lack of having a quorum; and 17 WHEREAS, the Sustainable Groundwater Management Act of 2014, which includes 18 Water Code Sections 10720-10736.6 (SGMA) was signed into law on September 16, 2014, and 19 requires that each California groundwater basin or subbasin be managed by a Groundwater 20 Sustainability Agency (GSA) or multiple GSAs, and that such management include an approved 21 22 Groundwater Sustainability Plan (GSP) or multiple GSPs subject to Water Code sections 1 23 0727(b) (3) and 10727.6. 24 WHEREAS, since the passage of SGMA, 15 GSAs have been formed throughout Fresno 25 County to address management of groundwater resources; and 26 WHEREAS, many of the current WAC members are also members of the newly formed 27 GSAs: and

WHEREAS, Fresno County participates in all of the 15 GSAs and has determined that
