DECLARATION OF INTENT AS TO
APPOINTMENT OF ALTERNATES TO
SERVE AS REGULAR MEMBERS ON
THE ASSESSMENT APPEALS BOARD

WHEREAS, each member of the Board of Supervisors of
the County of Fresno has nominated one member to serve
as a member of the Assessment Appeals Board pursuant to Revenue
and Taxation Code Section 1623.1 and Fresno County Ordinance
Code 2.64.010, et seq.; and

WHEREAS, each nominee has been appointed by the Board
to serve as a member to the Assessment Appeals Board and, of
those appointed, three have been selected as regular members
and two as alternate members; and

WHEREAS, alternate members may not serve except when
regular members have been temporarily unable to act pursuant to
Revenue and Taxation Code 1622.5; and

WHEREAS, alternates to the Assessment Appeals Board
have acquired experience by serving, or being prepared to serve
as required, on the Assessment Appeals Board when regular
members have been temporarily unable to act pursuant to Revenue
and Taxation Code 1622.5;

NOW, THEREFORE, BE IT RESOLVED that the Board of
Supervisors declares its intention to appoint alternates to
become regular members of the Assessment Appeals Board upon
the expiration of any term of office or the occurrence of a
vacancy, by whatever means, of a regular member.

This Declaration does not intend to bind future
Boards of Supervisors as a declaration of policy but to endorse
an appointment procedure that will enable alternates to serve

1 as regular members on the Board in order to secure regular
2 members who have gained experience by virtue of their
3 service as alternates to the Assessment Appeals Board.

4 THE APPOINTMENT procedure so endorsed is as follows.
5 The two alternates should be designated as Alternate #1
6 and Alternate #2. When there is a vacancy among the regular
7 members, or when the term of a regular member having served
8 a full three year term expires, Alternate #1 should be
9 appointed to that regular member position. Alternate #2
10 should then be appointed as Alternate #1, and any new
11 appointment should be made to the Alternate #2 position.
12 A vacancy occurring in the Alternate #1 position should be
13 filled by appointing Alternate #2 to the Alternate #1
14 position and a new appointment made to the Alternate #2
15 position.

16 THE FOREGOING RESOLUTION was passed and adopted by the
17 following vote of the Board of Supervisors of the County of
18 Fresno this 3rd day of October, 1978, to wit:
