## OF THE COUNTY OF FRESNO STATE OF CALIFORNIA ORDINANCE NO. 17-018

AN ORDINANCE AMENDING THE ORDINANCE CODE OF THE COUNTY OF FRESNO BY REPEALING SECTION 2.28.059, AMENDING THE TITLE OF CHAPTER 2.32, AND AMENDING SECTION 2.32.090. THIS ORDINANCE REPEALS THE CONSOLIDATION OF THE OFFICES OF DISTRICT ATTORNEY AND PUBLIC ADMINISTRATOR AND CONSOLIDATES THE OFFICES OF THE SHERIFF-CORONER AND PUBLIC ADMINISTRATOR.

The Board of Supervisors of the County of Fresno ordains as follows:

Section 1: The Ordinance Code of the County of Fresno is hereby amended by repealing Section 2.28.059 of Chapter 2.28 of Title 2 thereof.

Section 2: The Ordinance Code of the County of Fresno is hereby amended by amending the title of Chapter 2.32 of Title 2 thereof, to read in its entirety as follows:

"SHERIFF-CORONER-PUBLIC ADMINISTRATOR"

Section 3: The Ordinance Code of the County of Fresno is hereby amended by amending Section 2.32.090 of Chapter 2.32 of Title 2 thereof, to read in its entirety as follows:

"Pursuant to the authority vested in the Board of Supervisors by virtue of Section 14 of the Charter of the County of Fresno the offices of Sheriff-Coroner and Public Administrator, respectively, are consolidated into one office known as Sheriff-Coroner-Public Administrator of the County; the duties of which, including those performed in ex officio capacity, shall be performed by one person elected to such office in the manner prescribed by law. Whenever the term "Sheriff-Coroner" or "Public Administrator" appear in this code, it shall be construed to mean Sheriff-Coroner-Public Administrator."

Section 4: This Ordinance shall take effect and be in force thirty (30) days from and after its passage, but shall not be operative as to the duties or salaries of the offices affected until the commencement of new terms of office in January 2019.
