WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations of the District Attorney Org 2860; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector be authorized to increase the appropriations in the FY 2017-18 District Attorney Org 2860 as follows:
