

FIRST AMENDMENT TO AGREEMENT

This FIRST AMENDMENT TO AGREEMENT ("Amendment") is made and entered into this 14th day of November, 2017, by and between COUNTY OF FRESNO, a political subdivision of the State of California ("COUNTY"), and United Rentals (North America), Inc. a Delaware Corporation, whose address is 5741 S. Toyota Avenue, Fresno, CA 93725 ("CONTRACTOR").

WITNESSETH:

WHEREAS, COUNTY and CONTRACTOR entered into Agreement number A-16-657, dated November 15, 2016 ("Agreement"), pursuant to which CONTRACTOR agreed to provide heavy equipment rental to COUNTY; and

WHEREAS, the COUNTY'S annual need for heavy equipment rentals for the Road Maintenance Division of its Public Works & Planning Department has increased; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in order to increase the maximum expenditures under the Agreement, accordingly.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. The portion of Section 5 COMPENSATION of the Agreement, located on page 2, lines 20-23, is deleted in its entirety and replaced with the following:

3 covenants, conditions and promises contained in the Agreement and not amended herein
4 shall remain in full force and effect.






