WHEREAS, the County, in cooperation with the California Department of Transportation, has secured funding from the Federal Highway Bridge Program for the replacement of the existing bridge on Nees Avenue crossing the Delta Mendota Canal; and

WHEREAS, in order to accommodate the high volume of traffic on Nees during the replacement, a temporary detour bridge is to be installed adjacent to the existing bridge to convey traffic around the construction zone; and

WHEREAS, the County has adequate permanent right-of-way to accommodate the wider replacement bridge, but needs permission from the United States Bureau of Reclamation to install the temporary bridge on Federal land; and

WHEREAS, in order to receive such permission from the United States Bureau of Reclamation, an SF 299 form must be submitted; and,

WHEREAS, it is desired that the Director of the Department of Public Works and Planning be authorized to submit said form and to pay the associated fee; and

WHEREAS, it is necessary to execute a Letter of Agreement with the United States Bureau of Reclamation to receive permission to use property under the control of the United States Bureau of Reclamation; and

WHEREAS, it is desired that the Director of the Department of Public Works and Planning be authorized to execute said Letter of Agreement and to pay the

1 associated fee; and

2 WHEREAS, it is necessary to execute a Temporary Construction Permit with
3 the United States Bureau of Reclamation to receive permission to use property under
4 the control of the United States Bureau of Reclamation; and

5 WHEREAS, it is desired that the Director of the Department of Public Works
6 and Planning be authorized to execute said Temporary Construction Permit and to
7 pay the associated fee, subject to the approval of County Counsel and of the Auditor-
8 Controller / Treasurer-Tax Collector.

9 NOW, THEREFORE, IT IS HEREBY RESOLVED that the Board of
10 Supervisors of the County of Fresno hereby authorizes the Director of its Department
11 of Public Works and Planning to submit an SF 299 form to the United States Bureau
12 of Reclamation and to pay the associated fee for the Nees Avenue Bridge
13 replacement Project; and,


14 IT IS HEREBY FURTHER RESOLVED that the Board of Supervisors of the

16 and Planning to execute a Letter of Agreement with the United States Bureau of
17 Reclamation and to pay the associated fee for the Nees Avenue Bridge replacement
18 Project; and,


19 IT IS HEREBY FURTHER RESOLVED that the Board of Supervisors of the

23 with the United States Bureau of Reclamation, and to pay the associated fee for the
24 Nees Avenue Bridge replacement Project.
