

Fresno County Project Grant Questions

<p>1. Please briefly describe your proposed program, project or initiative. <u>(200 Words Max)</u></p>	<p>The Fresno County Public Defender's Office is requesting seed support for the newly established Clean Slate Program in and for Fresno County. The Clean Slate Program, also known as a reentry program, would assist low-income or indigent persons with post-conviction relief and help connect them to services that facilitate healthcare, employment and housing access. The program would assist individuals with applying for Expungements, Certificates of Rehabilitation, and various other post-conviction relief services. Program participants can receive services via a bimonthly clinic and weekly personal consultations. The program will work in partnership with the Fresno Housing Authority (HUD) to refer participants for assistance with HUD's Voucher Program. A successful expungement can make an individual eligible for: housing, job placement/advancement, financial aid, immigration relief, and many federal government assistance programs such as healthcare. Additionally, a reentry program such as this not only increases the participant's earning potential but it also decreases their need for government assistance and helps reunify families through better economic and health stability.</p>
<p>2. Please briefly describe the community health need or opportunity that this program, project or initiative will address. <u>(150 Words Max)</u></p>	<p>Unemployment can have devastating consequences for a former offender. For example, unemployed workers are 83% more likely to have heart disease, increased blood pressure, stress disorders, unhealthy coping behaviors, and increased depression. The Fresno Superior Court reports that drug court participants who are unable to secure housing and employment will have increased health consequences, and are more susceptible to HIV and overdose. In fact, increased income benefits allow the individual and their family to live healthier lives, have better access to healthy food and healthcare, and ultimately better daycare and support for their children. A successful expungement can lead to self-sufficiency, fiscal stability, improved mental health, and ultimately stronger families and community network ties.</p>

If you previously received Endowment support to work on this need or opportunity, please briefly describe the results and accomplishments of the prior grant, and explain how this new grant would build on those results and accomplishments. <u>(150 Words Max)</u> (If no previous Endowment grant, please enter "n/a".)</p>	<p>The office received a small grant of \$25,000 for the 2016-2017 fiscal year. The purpose of the grant was to conduct outreach for Proposition 47 – recently passed legislation that made many nonviolent felonies into misdemeanors. Along with educating the community about this new post-conviction relief, we also assisted eligible individuals with applying for this relief. As of April 5, 2017, we assisted 134 people in applying for Proposition 47 and 64 relief. Additionally, the program helped create and strengthen our relationship with community partners. We would like to enhance our services with a new grant by expanding the types of post-conviction relief we offer such as Expungements and referrals to housing, employment and healthcare services.</p>
<p>4. How is your organization uniquely qualified to undertake this work and achieve the targeted changes. <u>(150 Words Max)</u></p>	<p>The Public Defender's office is the only not-for-profit criminal law office in Fresno County. While there are other legal aid offices in the county, their services are civil in nature. The other two criminal law offices that assist indigent defendants are for-profit agencies and are composed of independent contractors. The Public Defender's Office has been offering services such as these for the last 50 years and has established a relationship with the many individuals who would benefit from a program such as this.</p>
<p>5. Please briefly describe how your proposed program, project or initiative relates to the efforts of other organizations working on the same issue, with the same population and/or in the same geographic area, as well as, how it relates to the BHC collaborative work. <u>(150 Words Max)</u></p>	<p>The Fresno Superior Court and law enforcement have tangential interests in the Clean Slate Program. If a former offender is unable to secure employment and housing, they are more likely to relapse or reoffend. The Department of Social Services (DSS) and the Economic Opportunities Commission (EOC) each have some form of reentry program whether it be securing driver's licenses and reducing court fines, to increasing employability, to job training and assistance with reintegration. The Public Defender's Office has collaborated with both of these organizations to expand these programs to include post-conviction relief. As discussed above, increasing a participant's earning potential helps the participant successfully reintegrate into the community, their family, and increases the health benefits to the participant and their family.</p>

Responsible for managing the Clean Slate Program including all aspects of operations, training, and applicant assistance.

Paralegal II @ .5 FTE.....\$14,661
Assist in filling out judicial council forms, copies, filtering calls, pulling records from all databases, drafting template letters, assisting during drop-in hours, answering eligibility questions – all under the supervision of the attorney.

Benefits @ 32%\$17,733
Calculated at 78% of salaries; (Retirement 57.18%; Medical 12%; FICA Medicare 1.45%; FICA Social Security 6.2%; Unemployment Insurance .1%; Workers' Comp .92%; Benefit Administration .15%), only requesting the maximum allowed by The California Endowment 32%.
