WHEREAS, \$7,500,000 is needed for the West Annex Jail (WAJ) project in the FY 2017-18 Central Plant/Tunnel (WAJ) Organization 8847; and

WHEREAS, \$4,591,524 has been appropriated in the Central Plant/Tunnel (WAJ) Organization 8847; and

WHEREAS, \$2,908,476 is needed in the FY 2017-18 Central Plant/Tunnel (WAJ) Organization 8847; and

WHEREAS, the Central Plant/Tunnel (WAJ) will receive \$2,908,476 as an Operating Transfer In from the General Fund 0001, Interest and Miscellaneous Organization 2540; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Central Plant/Tunnel (WAJ) Organization 8847; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Central Plant/Tunnel (WAJ) Organization 8847 as follows:




